A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING ATTACHED "PUBLIC TRANSPORTATION AGREEMENT" (PTGA) BETWEEN FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR SECTION 5311 GRANT PROGRAM FUNDING ASSISTANCE FOR FY 2018-19 FOR OPERATING EXPENSES OF THE FIXED ROUTE BUS TRANSIT SYSTEM IN KEY WEST IN AN AMOUNT NOT TO EXCEED \$466,649.00 (50% OF THE PROGRAM OF \$933,298.00)[FDOT FINANCIAL PROJECT NUMBER 434896-1-84-01, CONTRACT #G1268]; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS NECESSARY BUDGET AMENDMENTS: PROVIDING AN EFFECTIVE DATE;

WHEREAS, the State of Florida Department of Transportation (FDOT), via the Section 5311 Grant Program, provides funding assistance for operating expenses of the fixed route bus transit system in an amount not to exceed 50% of the total project cost at \$933,298.00, or reimbursement of up to \$466,649.00 in operating assistance; and

WHEREAS, in Resolution 17-146, the City Commission authorized certain members of City staff to apply for and accept grant funding, and to execute and submit grant documentation through the Transportation Electronic Award Management System; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Public Transportation Grant Agreement" is hereby approved, between FDOT and the City, for Section 5311 Grant Program funding assistance for FY 2018-19 for operating expenses of the fixed route bus transit system in an amount not to exceed \$466,649.00 (50% of the program cost of \$933,298.00). [FDOT Financial Project Number 434896-1-84-01, Contract #G1268]

Section 2: That the City Manager or his designee is authorized to effectuate any necessary budget transfers in accordance with such grant, and to execute any necessary documents.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
