A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "FIRST AMENDMENT TO CONTRACT" TO THE "AGREEMENT FOR OPERATIONS, MAINTENANCE, AND MANAGEMENT SERVICES FOR THE CITY OF KEY WEST, FLORIDA, WASTEWATER FACILITIES" BETWEEN THE CITY AND OPERATIONS MANAGEMENT INTERNATIONAL, INC. (OMI); AUTHORIZING A FIVE-YEAR RENEWAL, PURSUANT TO SECTION 4.1 OF THE AGREEMENT; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY PAPERWORK UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 13-304 the City Commission approved an Agreement with OMI to operate, maintain and manage the City's Wastewater Treatment Facilities; and

WHEREAS, City staff and OMI have requested an amendment to Section 2.5 of the Agreement, specifically amending the Direct Cost process for electricity charges, which is expected to save the City additional funds; and

WHEREAS, City staff recommends approval of a five-year renewal term, pursuant to Section 4.1 of the contract; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF
THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "First Amendment to
Contract", amending Section 2.5 of the "Agreement for
Operations, Maintenance, and Management Services for the City
of Key West, Florida, Wastewater Facilities" is hereby
approved.

Section 2: That the contract is renewed for a term
of five years, pursuant to section 4.1 of the Contract.

Section 3: That the City Manager, upon the advice and
consent of the City Attorney, is authorized to execute any
necessary documents.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
