A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE FOR THE FIRE DEPARTMENT OF FOUR (4) STRYKER POWER-PRO XT EMS STRETCHERS PLUS ACCESSORIES FROM STRYKER EMS EQUIPMENT, BY PIGGYBACKING ON SEMINOLE COUNTY CONTRACT IFB-602336-15/TLR, PURSUANT TO GOVERNMENT CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES IN A TOTAL AMOUNT NOT TO EXCEED \$79,344.00; AUTHORIZING NECESSARY BUDGET TRANSFERS TO USE "ASSISTANCE TO FIREFIGHTERS GRANT" FUNDING AND CITY FUNDING TO COMPLETE THE PURCHASE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 18-313 the City Commission accepted and ratified Grant No. EMW-2017-FO-04301 from the Department of Homeland Security/FEMA Assistance to Firefighters Grant Program in the amount of \$72,131.00 (\$7,213.00 city match) for the purchase of four power lift cots; and

WHEREAS, Key West Fire Department staff has recommended the purchase of four (4) Stryker Power-Pro XT EMS Stretchers from Stryker EMS Equipment, by piggybacking on the Seminole County Contract, pursuant to section 2-797(3) of the Code of Ordinances; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF
THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of four (4) Stryker Power-Pro XT-EMS Stretchers in a total amount not to exceed \$79,344.00, from Stryker EMS Equipment, by piggybacking on the Seminole County contract IFB-602336-15/TLR, pursuant to section 2-797(3) of the code of ordinances is hereby approved.

Section 2: That funding for this purchase is received through Grant No. EMW-2017-FO-04301 from the Department of Homeland Security/FEMA Assistance to Firefighters Grant Program in the amount of \$72,131.00. City matching funds in the amount of \$7,213.00 will be funded using surplus funds from previous projects through the Infrastructure Surtax accounts 101-2601-526-6400 and 101-2201-526-6400, and any necessary transfers to effectuate this purchase are authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
