An application was received requesting the removal of **(1) Pink Tabebuia and (1) Gumbo Limbo tree**. A site inspection was done and documented the following:



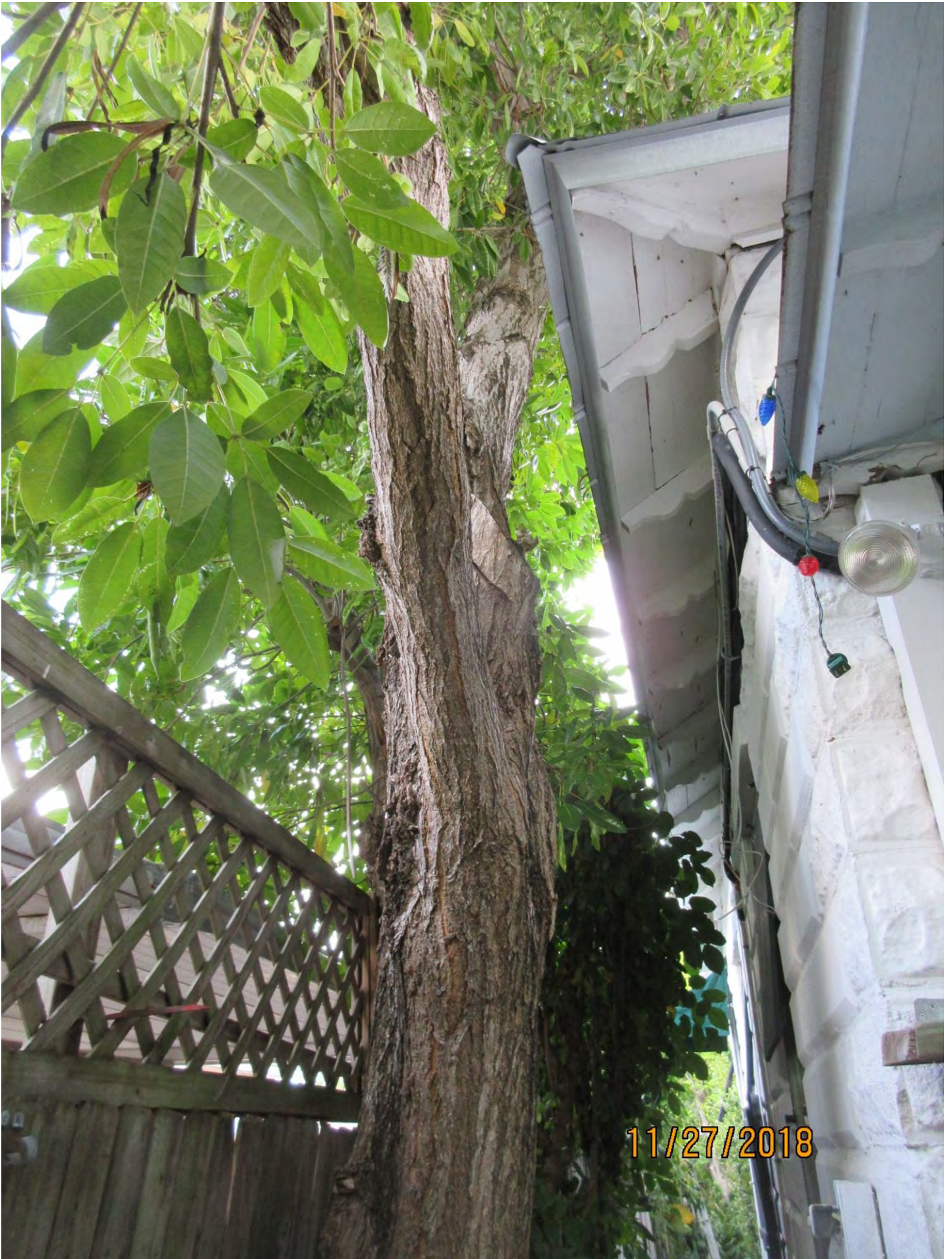
Tree Species: Pink Tabebuia (*Tabebuia heterophylla*)





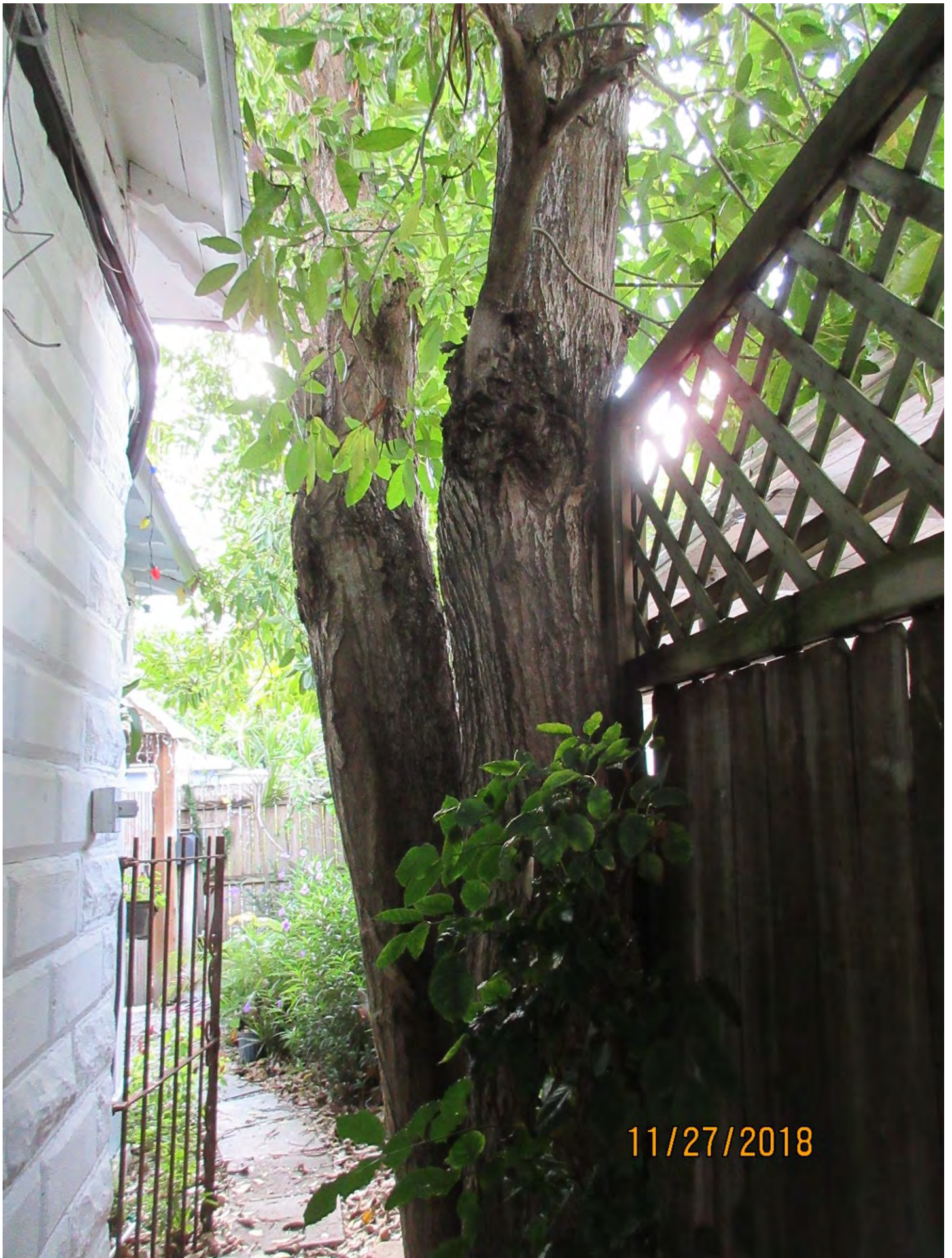

Diameter: $27.3'' - 24'' = 2.3''$

Location: 60% (tight area, close to house)

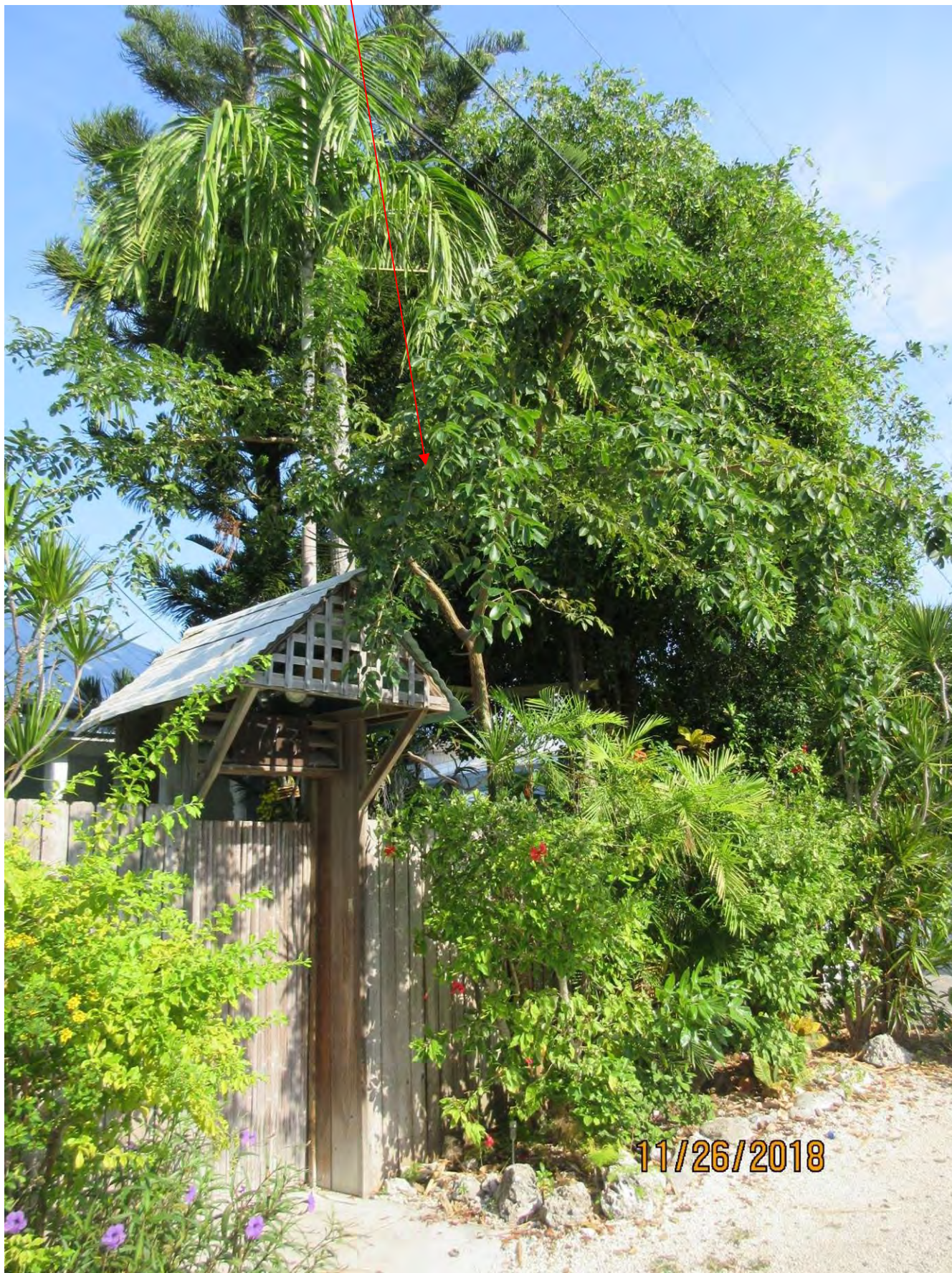
Species: 0% (on not protected tree list)

Condition: 60% (fair, low codominant trunks, poor structure)

Total Average Value = 40%

Value x Diameter = 0.9 replacement caliper inches

Tree Species: Gumbo Limbo (*Bursera simaruba*)

Diameter: 4.4"

Location: 40% (under utility lines, against fence—volunteer tree)

Species: 100% (on protected tree list)

Condition: 60% (fair, young tree, lopsided growth and canopy)

Total Average Value = 66%

Value x Diameter = 2.9 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Pink Tabebuia and (1) Gumbo Limbo at 1713 Washington Street to be replaced with 3.8 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

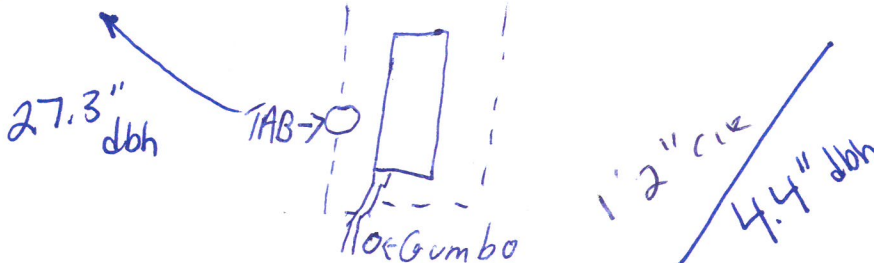

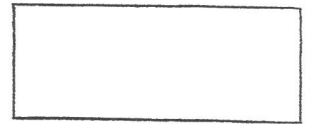
<<<<< Sketch location of tree in this area including cross/corner Street >>>>>
