A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF A REPLACEMENT ALLEN-BRADLEY BY ROCKWELL VARIABLE FREQUENCY DRIVE (VFD) AND CONTROL PANEL FROM REXEL, INC., ON A SOLE SOURCE BASIS, AND IN THE BEST INTERESTS OF THE CITY, PURSUANT TO SECTION 2-797(1) AND 2-797(4)(b) OF THE CODE OF ORDINANCES, IN A TOTAL AMOUNT NOT TO EXCEED \$136,000.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, Rexel, Inc. is the only source for the Allen-Bradley by Rockwell VFD and controller necessary for effluent pump FP-3-1 at the Richard A. Heyman Environmental Pollution Control Facility;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of an Allen-Bradley by Rockwell VFD and control panel from Rexel, Inc. is hereby approved on a sole source basis, pursuant to Code of Ordinances Section 2-797(1), sole source procurement, and Section 2-797(4)(b), best interests of the City, in an amount not to exceed \$136,000.00.

Section 2: That this purchase is funded through budget account Utilities/Sewer/WWTP/CIP 401-3504-535-6500, Project Number SE350331701.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
