A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF A.C. SCHULTES OF FLORIDA, INC., IN RESPONSE TO ITB 19-007 FOR WASTEWATER TREATMENT PLANT (WWTP) WELL REPAIR AND MECHANICAL INTEGRITY TEST PROJECT IN THE AMOUNT OF \$51,600.00; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN CONFORMANCE WITH THE BID DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on December 20, 2018, three bid(s) were opened for ITB 19-007, WWTP Well Repair and Mechanical Integrity Testing, for the repair of well IW-1 and mechanical integrity testing for IW-1 and IW-2 wells at the Wastewater Treatment Plant; and

WHEREAS, the bid of A. C. Schultes of Florida, Inc. was the lowest responsive and responsible bid, and City staff recommends award of the bid accordingly; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of A.C. Schultes of Florida, Inc. in the amount of \$51,600.00 is hereby awarded, in response to ITB 19-007 for the WWTP Well Repair and Mechanical Integrity Testing Project.

Section 2: That adequate funding for the well repair project is budgeted in Utilities/Sewer/WWTP/CIP 401-3504-535-6500 Project SE35041701, and the mechanical integrity testing is

budgeted in account Utilities/Sewer/WWTP/Professional Services, and any necessary budget adjustments are hereby authorized.

Section 3: That the City Manager is authorized to enter into a contract in conformity with the bid documents upon the consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
