#### JOINT VENTURE, ASSIGNMENT AND SUBCONTRACTOR AGREEMENT

This Joint Venture, Assignment and Subcontractor Agreement ("Agreement") is entered into on this  $30^{\text{th}}$  day of November 2018, by and between EE&G Construction & Electrical, LLC its successor and/or assigns ("EE&G"), and Safe Harbor Industries, Inc., its successor and/or assigns ("SHI"), sometimes collectively referred to herein as the "Parties", for bidding on and performing the City of Key West ("City") Smathers and Rest Beach Cleaning Services, Invitation to Bid #19-003.

#### RECITALS

WHEREAS, EE&G Environmental Services, LLC ("EE&G Environmental") currently is under contract with the City to perform the City of Key West Smathers and Rest Beach Cleaning Services Contract dated December 20, 2013 (2013 Beach Cleaning Contract) and has subcontracted with SHI, and Hugh Spinney to perform, conduct, and supervise the day to day operations of cleaning and maintaining the City of Key West's Smathers and Rest Beach under the 2013 Beach Cleaning Contract; and

WHEREAS, EE&G Environmental no longer wishes to pursue the beach cleaning business after completion of the 2013 Beach Cleaning Contract terminates which should occur prior to the end of the calendar year 2018; and

WHEREAS, EE&G Construction & Electrical, LLC ("EE&G") shall be EE&G Environmental's successor in interest for purposes of bidding on and performing beach cleaning and similar type services; and

WHEREAS, City has issued an Invitation to Bid ("ITB") for the City's Smathers and Rest Beach Cleaning Services ("Beach Cleaning"); and

WHEREAS, EE&G has reviewed the ITB for the City's Beach Cleaning and has elected to bid on the City's Beach Cleaning, and if successful in being awarded the bid, EE&G has agreed to subcontract the day to day operations to SHI to perform the day to day operations under the supervision of EE&G; and

WHEREAS, City Code Section 2-798 provides that the City is required to give preference in awarding contracts in certain instances to local businesses and joint ventures which consist of a local and non-local business; and

WHEREAS, SHI qualifies as a local business pursuant to City Code Section 2-798 and EE&G and SHI would qualify as a Joint Venture if the Parties agreed to bid the Beach Cleaning as a joint venture; and

WHEREAS, the Parties have agreed to form a joint venture for purposes of bidding on the City's Beach Cleaning in order to obtain the most advantageous position against potential non-local businesses.

**NOW THEREFORE**, in consideration of the mutual promises and consideration contained herein, the Parties agree as follows:

#### TERMS

1. <u>**RECITALS.**</u> The foregoing recitals are true and correct and are incorporated herein by reference.

#### 2. JOINT VENTURE AGREEMENT.

- a. The Parties agree to form a joint venture for the sole and exclusive purpose of bidding on the City's beach cleaning services.
- b. The Parties agree that neither party may bind the other party except for the limited purpose of procuring and being awarded the beach cleaning contract.
- c. The Parties agree that the Joint Venture shall not control the Parties relationship for performance under the Beach Cleaning contract which relationship shall be governed by Paragraph 4.
- d. The Parties agree that the joint venture shall terminate immediately upon assignment of the Beach Cleaning contract to EE&G, or in the case that the Parties are not awarded the Beach Cleaning contract, immediately upon the acceptance of the Beach Cleaning contract by another entity.
- e. SHI agrees that it shall continue to qualify as a local business pursuant to City Code Section 2-798.
- 3. <u>ASSIGNMENT</u>. The Parties agree that the joint venture contemplated under paragraphed 2 shall immediately assign the Beach Cleaning contract to EE&G upon award of the Beach Cleaning contract to the joint venture.
- 4. <u>SUBCONTRACTING OF SHI</u>. EE&G agrees to subcontract the day to day operations of the Beach Cleaning to SHI. The parties agree to enter into a more detailed subcontractor agreement upon being awarded the Beach Cleaning by City.
- 5. <u>CONFIDENTIALITY</u>. The terms of this Agreement shall remain confidential and this Agreement's terms hereof shall not be disclosed to anyone except (i) as may be necessary to the Parties' respective attorneys, accountants, spouses, or agents, or (ii) to enforce the terms of this Agreement. In the event any of the Parties to this Agreement may be called upon to disclose the terms of this Agreement by subpoena, then before producing this Agreement or disclosing its contents by way of testimony,

the party receiving or being served such a subpoena shall, within five (5) days of receipt or service, provide a copy of the subpoena along with written notice to the other party to this Agreement of receipt and notifying the other party of the subpoena of its intent to not object to said subpoena, and provide a minimum of ten (10) days (or such notice as may be reasonable under the circumstances) to allow the other party an opportunity to seek an appropriate order preventing or limiting disclosure of this Agreement.

- a. The Parties further agree that this confidentiality provision is enforceable by way of injunctive relief prohibiting the disclosure of any term of this Agreement and all Parties hereby consent to the entry of an injunction prohibiting disclosure of this Agreement to anyone other than Parties hereto.
- 6. **INTERPRETATION**. The Parties hereto each represent and warrant to each other that (i) they have had sufficient time to review this Agreement and consult with counsel of their choice, (ii) they have received such advice as they deem necessary as to their legal rights under, and the validity and enforceability of, this Agreement, and (iii) they fully understand the content and legal effect of this Agreement. Moreover, the principle of construing a document most strictly against its drafter shall not apply with respect to the interpretation of this Agreement rather the interpretation of this Agreement.
- 7. ENTIRE AGREEMENT. This Agreement (including any exhibits attached hereto) constitutes the entire agreement and contract between the Parties hereto pertaining to the subject matter hereof. This Agreement supersedes all prior or contemporaneous agreements, representations or negotiations between the Parties hereto, and cannot be modified or amended except in writing executed by each of the Parties.
- 8. **SEVERABILITY.** In the event that any one or more of the provisions of this Agreement is held void, voidable, invalid, illegal, or unenforceable for any reason, then said provision shall be deemed to be severed and removed from this Agreement and the remainder of this Agreement shall remain in full force and effect as if said provision had never been contained herein.
- 9. <u>GOVERNING LAW</u>. This Agreement shall in all respects be construed in accordance with and governed by the laws of the State of Florida, without regard to conflict-of-law rules. The Parties expressly agree that any dispute arising in connection with this Agreement shall be filed in the Circuit Court of the Sixteenth Judicial Circuit in and for Monroe County, Florida, and each party hereby consents to

jurisdiction in said Court and waives any objections it may have to that Court's exercise of personal jurisdiction over them.

- 10. **ATTORNEYS' FEES.** In the event that any of the Parties brings any litigation involving or arising out of this Agreement, then the prevailing party shall be entitled to recover its reasonable attorneys' fees and costs, including appellate fees.
- 11. <u>AUTHORITY TO EXECUTE</u>. Each individual signing this Agreement on behalf of any person or entity expressly represents and warrants that he or she has the right, legal capacity, and full authority to execute this Agreement.
- 12. **BINDING EFFECT AND COOPERATION.** This Agreement shall be binding upon and inure to the benefit of the Parties hereto and their respective legal representatives, successors and assigns. The Parties hereby agree to cooperate in executing any further documentation that might be necessary to effectuate this Agreement.
- 13. **PARAGRAPH HEADINGS.** Headings used in this Agreement are for reference purposes only and shall not be deemed to have any substantive effect.
- 14. <u>COUNTERPARTS</u>. This Agreement may be executed in counterparts, including by facsimile, all of which together shall constitute one and the same instrument.

# **BIDDING REQUIREMENTS**

#### **INVITATION TO BID**

Sealed bids for the City of Key West ITB # 19-003 SMATHERS & REST BEACH CLEANING, addressed to the City of Key West, will be received at the Office of the City Clerk, 1300 White Street., Key West Florida, 33040 until 3:00 p.m. on Wednesday, December 19, 2018 and then will be publicly opened and read. Any bids received after the time and date specified will not be considered.

Please submit one (1) original, and two (2) flash drives each with one single PDF file of the sections entitled "Bidding Requirements" and "Contract Forms". Bid package is to be enclosed in a sealed envelope, clearly marked on the outside "ITB #19-003 BID FOR "SMATHERS & REST BEACH CLEANING" addressed and delivered to the City Clerk at the address noted above.

The project consists of providing all materials, equipment and labor necessary to clean Smathers Beach daily for three (3) years and Rest Beach fifty-two (52) times a year for 3 years with an option to extend for two (2) years at the unit prices stated in the Bid plus Consumer Price Index (CPI) increases. Cleaning consists of seaweed sifting and removal using a Cherrington 5450 Beach Cleaner and a Barber 600 HD beach rake with tractor, or equal, and other specified equipment. Debris, trash, and litter removal from all areas of the beaches as described in this Invitation to Bid is also included.

A Mandatory Pre - Bid meeting will be held on November 28, 2018 at 10:00 a.m. at the Smathers Beach Restrooms, 2018 South Roosevelt Boulevard, Key West, Florida

#### EACH BID MUST BE SUBMITTED ON THE PRESCRIBED FORM AND ACCOMPANIED BY BID SECURITY AS PRESCRIBED IN THE INSTRUCTIONS TO BIDDERS, PAYABLE TO THE CITY OF KEY WEST, FLORIDA, IN AN AMOUNT NOT LESS THAN FIVE (5) PERCENT OF THE AMOUNT BID.

## THE BIDDER MUST BE A LICENSED CONTRACTOR BY THE STATE OF FLORIDA AND SUBMIT PROOF OF SUCH WITH THE BID.

The successful Bidder shall furnish documentation showing that he is in compliance with the licensing requirements of the State and the provisions of Chapter 66 Section 87 of the Code of Ordinances of the City of Key West; within 10 days following the Notice of Award and must demonstrate that he holds at a minimum, the following licenses & certificates;

- A. City of Key West Business Tax License Receipt
- B. A valid Certificate of Competency issued by the Chief Building Official of Key West, Florida.

All bid bonds, insurance contracts, and certificates of insurance shall be either executed by or countersigned by a licensed resident agent of the Surety or Insurance Company having his place of business in the State of Florida, and in all ways complying with the insurance laws of the State of

Florida. Further, the said Surety or Insurance Company shall be duly licensed and qualified to do business in the State of Florida.

Before a Contract will be awarded for the work contemplated herein, the CITY will conduct such investigation as is necessary to determine the performance record and ability of the apparent low Bidder to perform the size and type of work specified under this Contract. Upon request, the Bidder shall submit such information as deemed necessary by the CITY to evaluate the Bidder's qualifications.

Any request for information concerning this project must be made in writing, per City of Key West Ordinance Section 2-773, Cone of Silence, to Marcus Davila, Director of Community Services, at madavila@cityofkeywest-fl.gov. Responses will be by way of Addendum.

As stated above at the time of the bid submittal the Bidder must provide satisfactory documentation of State Licenses. The Bidder shall furnish documentation showing that he is in compliance with the licensing requirements of County, and City licenses as would be required within ten days of the award. The successful Bidder must also be able to satisfy the CITY Attorney as to such insurance coverage and legal requirements as may be demanded by the Bid in question. The CITY may reject bids for any and/or all of the following reasons: (1) for budgetary reasons, (2) if the bidder misstates or conceals a material fact in its bid, (3) if the bid does not strictly conform to the law or is non-responsive to the bid requirements, (4) if the bid is conditional, or (5) if a change of circumstances occurs making the purpose of the bid unnecessary to the CITY. The CITY may also waive any minor formalities or irregularities in any bid, (6) if such rejection is in the best interest of the CITY.

#### **INSTRUCTIONS TO BIDDERS**

#### 1. <u>CONTRACT DOCUMENTS</u>

#### A. <u>FORMAT</u>

The Contract Documents are divided into parts, divisions, and sections for convenient organization and reference. Generally, there has been no attempt to divide the sections into work performed by the various building trades, work by separate subcontractors, or work required for separate facilities in the project.

#### B. <u>DOCUMENT INTERPRETATION</u>

The separate sections contained within these Contract Documents are intended to be mutually cooperative and to provide all details reasonably required for the execution of the proposed work.

Should there be any doubt as to the meaning or intent of said Contract Documents, the Bidder should request of the COMMUNITY SERVICES DIRECTOR, in writing (at least ten (10) calendar days prior to bid opening) an interpretation thereof. Any interpretation or change in said Contract Documents will be made only in writing in the form of Addenda to the documents which will be available to all registered holders of Contract Documents via Demand Star. Bidders shall submit with their Bids, or indicate receipt of, all Addenda. The CITY will not be responsible for any other explanation or interpretations of said Documents.

#### 2. <u>GENERAL DESCRIPTION OF THE PROJECT</u>

A general description of the work to be done is contained in the Invitation to Bid. The scope is specified in applicable parts of these Contract Documents.

#### 3. <u>QUALIFICATION OF CONTRACTORS</u>

The prospective Bidders must meet the statutorily prescribed requirements before award of Contract by the CITY. Bidders must hold or obtain all licenses and/or certificates as required by the State and Local Statutes to bid and perform the work specified herein.

#### 4. <u>BIDDER'S UNDERSTANDING</u>

Each Bidder must inform himself of the conditions relating to the execution of the work, and it is assumed that he will inspect the site and make himself thoroughly familiar with all the Contract Documents. Failure to do so will not relieve the successful Bidder of his obligation to enter a Contract and complete the contemplated work in strict accordance with the Contract Documents. It shall be the Bidder's obligation to verify for himself and to his complete satisfaction all information concerning site and subsurface conditions.

The CITY will make available to prospective Bidders upon request and at the office of the COMMUNITY SERVICES DIRECTOR, prior to bid opening, any information that he may have

as to subsurface conditions and surface topography at the worksite.

Each Bidder shall inform himself of, and the Bidder awarded a Contract shall comply with, federal, state, and local laws, statutes, and ordinances relative to the execution of the work. This requirement includes, but is not limited to, applicable regulations concerning minimum wage rates, nondiscrimination in the employment of labor, protection of public and employee safety and health, environmental protection, the protection of natural resources, fire protection, burning and non-burning requirements, permits, fees, and similar subjects.

#### 5. <u>TYPE OF BID</u>

#### A. <u>LUMP SUM</u>

The BID for the work is to be submitted on a lump sum basis. Lump sum prices shall be submitted for all items of work set forth in the bid. All items required to complete the work specified but not included in the bid shall be considered incidental to those set forth in the bid.

#### 6. <u>PREPARATION OF BIDS</u>

#### A. <u>GENERAL</u>

All blank spaces in the BID form must be filled in, as required, preferably in BLACK ink. All price information shall be shown in both words and figures where required. No changes shall be made in the phraseology of the forms. Written amounts shall govern in case of discrepancy between the amounts stated in writing and the amounts stated in figures. In case of discrepancy between unit prices and extended totals, unit prices shall prevail.

Any BID shall be deemed informal which contains omissions, erasures, alterations, or additions of any kind, or prices uncalled for, or in which any of the prices are obviously unbalanced, or which in any manner shall fail to conform to the conditions of the published Invitation to Bid.

Only one BID from any individual, firm, partnership, or corporation, under the same or different names, will be considered. Should it appear to the CITY that any Bidder is interested in more than one Bid for work contemplated; all Bids in which such Bidder is interested will be rejected.

#### B. <u>SIGNATURE</u>

The Bidder shall sign his BID in the blank space provided therefore. If Bidder is a corporation, the legal name of the corporation shall be set forth above, together with the signature of the officer or officers authorized to sign Contracts on behalf of the corporation. If Bidder is a partnership, the true name of the firm shall be set forth above, together with the signature of the partner or partners authorized to sign Contracts in behalf of the partnership. If signature is by an agent, other than an officer of a corporation or a member

of a partnership, a notarized power-of-attorney must be on file with the CITY prior to opening of Bids or submitted with the Bid, otherwise the Bid will be regarded as not properly authorized.

#### C. <u>SPECIAL BIDDING REQUIREMENTS</u>

The Bidder's attention is brought to the hiring practices and licenses and permits of the City of Key West. These are defined in the addition to Article 39, ORDINANCES, PERMITS, AND LICENSES, as set forth in the Supplementary Conditions.

The Bidder shall submit with his Bid his experience record showing his experience and expertise in beach cleaning and related work. Such experience record shall provide at least five current or recent projects (within the past 5 years) of similar work, within the State of Florida. For each project the following information shall be provided:

- 1. Description and location of work.
- 2. Contract amount.
- 3. Dates work was performed.
- 4. Owner.
- 5. Name of Owner's contact person and phone number.

The bidder shall submit with his bid a list of items to be performed by his own labor and that performed by subcontractors or others.

#### D. <u>ATTACHMENTS</u>

Bidder shall complete and submit the following forms with his bid:

Anti-Kickback Affidavit Public Entity Crimes Form Indemnification Form City of Key West Business License Tax Receipt Local Vendors Form Domestic Partnership Affidavit Cone of Silence Affidavit Non-collusion Affidavit Bidders' Checklist

#### E. <u>PUBLIC ENTITY CRIMES FORM</u>

Pursuant to the requirements of Chapter 287.133, Laws of Florida, pertaining to the sworn statement on Public Entity Crimes and the Convicted Vendor List, all Bidders shall submit a signed and notarized statement with their Bid on the form provided herein.

#### 7. <u>STATE AND LOCAL SALES AND USE TAXES</u>

Unless the Supplementary Conditions contains a statement that the CITY is exempt from state

sales tax on materials incorporated into the work due to the qualification of the work under this Contract, the Contractor, as required by the laws and statutes of the state and its political subdivisions, shall pay all state and local sales and use taxes. Prices quoted in the Bid shall include all nonexempt sales and use taxes, unless provision is made in the Bid form to separately itemize the tax.

#### 8. <u>SUBMISSION OF BIDS</u>

All BIDS must be submitted not later than the time prescribed, at the place, and in the manner set forth in the Invitation to Bid. BIDS must be made on the BID forms provided herewith, submit one (1) ORIGINAL and two (2) FLASH DRIVES each containing a single PDF file of the entire bid package.

Each BID must be submitted in a sealed envelope, so marked as to indicate the Bidder's name and its contents (project name and number) without being opened and addressed in conformance with the instructions in the Invitation to Bid.

#### 9. MODIFICATION OR WITHDRAWAL OF BIDS

Prior to the time and date designated for receipt of BIDS, any BID submitted may be withdrawn by notice to the party receiving BIDS at the place designated for receipt of BIDS. Such notice shall be in writing over the signature of the Bidder or by telegram. If by telegram, written confirmation over the signature of the Bidder shall be mailed and postmarked on or before the date and time set for receipt of BID. No BID may be withdrawn after the time scheduled for opening of BIDS, unless the time specified in paragraph AWARD OF CONTRACT of these Instructions to Bidders shall have elapsed.

#### 10. <u>BID SECURITY</u>

BIDS must be accompanied by cash, a certified check, or cashier's check drawn on a bank in good standing, or a bid bond issued by a Surety authorized to issue such bonds in the state where the work is located, in the amount of five (5) percent of the total amount of the Bid submitted. This bid security shall be given as a guarantee that the Bidder will not withdraw his BID for a period of ninety (90) days after bid opening, and that if awarded the Contract, the successful Bidder will execute the attached Contract and furnish properly executed Performance and Payment Bonds, each in the full amount of the Contract price within the time specified. Agent and Surety phone numbers must be provided.

The Attorney-in-Fact who executes this bond in behalf of the Surety must attach a notarized copy of his power-of-attorney as evidence of his authority to bind the Surety on the date of execution of the bond. Where State Statute requires, certification by a resident agent shall also be provided.

If the Bidder elects to furnish a Bid Bond, he shall use the Bid Bond form bound herewith, or one conforming substantially thereto in form and content.

#### 11. <u>RETURN OF BID SECURITY</u>

Within 15 days after the award of the Contract, the CITY will return the bid securities to all Bidders ITB 19-003 6 SMATHERS & REST BEACH CLEANING INSTRUCTIONS TO BIDDERS whose BIDS are not to be further considered in awarding the Contract. 





HURRICANE IRMA, LA SIESTA RESORT, ISLAMORADA, FL – NATURAL DISASTER EMERGENCY CLEAN-UP AND RESTORATION SERVICES

**Description:** Hurricane Irma was regarded as one of the worst natural disaster on record for the Islamorada Keys of Florida. EE&G was retained by Baker Project Consulting, on behalf of the property owners to provide restoration services at the La Siesta Resort. La Siesta Resort consisted of 15 buildings that contained 54, 1 to 5 bedroom suites, an office, and laundry facility.

EE&G mobilized to the property as soon as access was permitted and power was restored to the area. EE&G's initial tasking included performing moisture mapping to identify the extent of the water impacts, securing the buildings to prevent additional water intrusion and drying out the affected areas. Once the extent of water impacts were ascertained, asbestos surveys were performed of locations where demolition of building materials was necessary. Following receipt of the asbestos results the water damaged materials were removed. The buildings were then confirmed to be dry and were prepared for reconstruction.



EE&G obtained the necessary permits and performed reconstruction services on the interior and exteriors of the buildings. Interior components that were replaced included framing, damaged

#### HURRICANE MARIA AND IRMA, NATURAL DISASTER – STEP PROGRAM-VARIOUS LOCATIONS – PUERTO RICO, EMERGENCY CLEAN-UP AND RESTORATION SERVICES

**Description:** Hurricanes Maria and Irma were regarded as the worst natural disaster on record for the Caribbean Island of Puerto Rico. EE&G was retained by Excel Contractors USA, 4 Contractors JV, and Yates-Bird, LLC including local institutions such as the United States Army Corps of Engineers to implement the Sheltering and Temporary Essential Power ("STEP") Program to enable the Puerto Rico government to perform minor emergency repairs in single-family owner-occupied residences in order for them to become habitable as shelters in place. #### HURRICANE MARIA AND IRMA, NATURAL DISASTER – BLUE TARP PROGRAM-VARIOUS LOCATIONS – PUERTO RICO, EMERGENCY CLEAN-UP AND RESTORATION SERVICES

PROJECT DESCRIPTION: Hurricane Maria was regarded as the worst natural disaster on record for the Caribbean Island of Puerto Rico. EE&G was retained by Ceres Environmental Services, Inc. to implement a program called "Operation Blue Roof," which was managed by the United States Army Corps of Engineers (USACE) and the Federal Emergency Management Agency (FEMA) who funded the project.

Operation Blue Roof is a temporary covering of reinforced blue plastic (tarp) sheeting using strips of wood secured to the roof with nails or screws to help reduce further damage to property until permanent repairs can be made. In order to be considered for this program, a homeowner / landlord was to legally agree to allow the USACE contractors access to the property by signing a Right of Entry (ROE) form. Blue Roofs are designed to last for 30 days.



EE&G provided supervision, work crews, materials, tools / equipment, permits, installation, shop drawings, field use drawings, reports and all other services necessary to expeditiously meet a daily goal of nearly 200 roofs per day. EE&G managed the flow of work to the subcontractors for Ceres Environmental and was a key subcontractor in completing the blue tarp installations.

FEMA and the USACE: FEMA and the USACE began the Operation Blue Roof project October 10th, 2017, one month after the eye of Hurricane Maria crossed the island. The purpose of the blue roof repair for Puerto Rican homeowners was to protect their homes from further damage caused by wind and rain. Under this program, EE&G successfully installed more than 10,000 roofs, contributing to the nearly 70,000 temporary blue roofs that the USACE oversaw in Puerto Rico in hurricane Maria's aftermath.

### **SECTION 4 SUBMITTALS**

EE&G understands the required services to be performed for this project, that is, EE&G shall be to clean and maintain the entire length and width of Smathers and Rest Beach areas within the water's edge to the curb line or nearest edge of the pavement of the public road nearest to and paralleling the beach area, seven days per week at Smathers Beach and 52 times a year at Rest beach weather and/or environmental conditions permitting. EE&G understands that the cleaning and maintaining of both beach areas shall begin following sunrise and be completed by 10:00am.

All seaweed will be removed from the beach and recycled per our Seaweed Disposal Plan presented in Item G. of this section of this submittal. All debris and trash removed from the beach will be collected in black garbage bags and will be placed in the City's leased roll-off dumpster on a daily basis.

#### **TURTLE NESTING STATUTES & ORDINANCES**

EE&G will adhere to all state and local statues/ ordinances regarding sea turtles. We understand that the City of Key West, Monroe County, Florida have beach activity regulations in City of Key West, Code of Ordinances, Chapter 10-Animals, Article VI.-Sea Turtles, regarding protection of sea turtles.

EE&G works with "Safe-A-Turtle" and sea turtle conservation groups during turtle nesting season (April 15 through October 31). EE&G clearly understands the importance of no beach cleaning activities taking place should nesting being found during inspection of beach, until Key West Turtle Club representatives and/or Save -a-Turtle Certified Turtle Inspector, have walked and cleared the beaches.

#### SUBMITTALS

The primary problem for Key West beaches is the daily accumulation of seaweed. The constant east, southeast winds produce a steady supply of seaweed. When seaweed is not removed properly daily, it decomposes in the shallow near shore waters. This causes a mucky bottom and decay of odors that are very undesirable for beachgoers.

After years of experience, EE&G has determined that the most effective way to solve this daily problem is by the use of a variety of equipment. For removing the seaweed on the beach areas, the Barber surf rake is the most effective beach cleaning machine. It is used by 80% of municipalities involved in beach cleaning.

In addressing the removal of debris; The Barber will remove 70 percent of all cigarette butts etc. and is most effective with seaweed. The perfect combination of machines would be the Barber and Cherrington.

A self-propelled Cherrington has the same sifting and debris removal capabilities of the Beach Tech, but has much smaller cleaning and hauling capacities. The self-propelled Cherrington can maneuver around trees, tables, and any obstacle with ease allowing it to clean the hard to get areas.



**Eastne:** The machine is furnished with a diesel engine of not more than 4 cylinders producing approximately 75 horsepower. The engine is of adequate size to propel the machine with all power accessories in operation The fuel system includes a water separator mounted at the engine to prevent condensed water in fuel lines from entering the injection systems.

**Drive System:** A closed loop hydrostatic drive transmits variable speed forward and reverse power to all wheels. A separate fixed displacement pump provides power to the hopper, hoist, dump, and digger-depth control cylinders, the screen oscillator motor, and the overhead conveyor motor. The speeds of the two motors can be varied. They can also be stopped or reversed to accommodate the requirements of the job at hand.

Wheels and Tires: The machine has one front and two rear wheels. Power steering is on the front wheel for best maneuverability. All tires are of a minimum size 38" x 14" high flotation. Reverse mounted flat profile barred tires provide flotation, stability, and traction in sand. Each tire can be fluid filled for added traction and/or lowered center of gravity.

Oscillating Screen and Digger: The machine is capable of digging a loose dry sand depth of zero to 6 inches, fully controlled hydraulically by the operator while the machine is in motion. The screens are made of Corten steel or oil tempered hardened woven wire and are available in various hole sizes. The digger points are of high carbon steel. The minimum cleaning width is four feet six inches. A T-bar overhead flight system bolted to three heavy duty steel (620 implement) chains is used to move debris collected on the screens into the hopper.

**Hopper:** The hopper has a capacity of one cubic yard. It is hydraulically operated for dumping with an eight foot six inch clearance in the raised position, capable of dumping into debris boxes or dump trucks. The dumping operation is fully controlled from the operator's normal seated position.



#### C. Schedule of Beach Cleaning.

EE&G will clean Smathers and Rest Beach's with a high quality of work and equipment. Daily schedule beginning first thing in the morning.

- A. Mobilize crew and equipment.
- B. Equipment Operator will wait for go ahead from the turtle watch group.
- C. The EE&G team will separate trash and debris by hand from seaweed prior to mechanical cleaning.
- D. The EE&G team will walk entire beach to clean debris from sand and rocks.
- E. After seaweed is cleaned of all trash and debris it will be raked up picked up by truck and moved to a class three landfill.
- F. The beach's will be groomed from low water mark landward daily using an approved beach cleaning machine.
- G. Beach and rock areas, will be cleaned of trash and debris daily and disposed of in dumpsters supplied by the county
- H. Beach area around trees, picnic tables and walkways will be hand cleaned. This area cannot be accessed by larger beach cleaning machine.
- I. All trash cans will be emptied and relined with new bags. Trash will be picked up by trailer and deposited in dumpster within 200 ft. of beach provided by the City.
- J. Team will sweep/blow off all walkways, handicap ramps and accesses daily starting at sidewalk and progressing beach ward to save sand.
- K. EE&G will provide Seaweed load report with Monthly invoice.
- L. EE&G will have an environmental plan in place along with daily maintenance schedule on equipment to insure that fuel, oil, hydraulic fluid leaks will be kept to a minimum.
- M. EE&G will have daily on site supervision.
- N. A scheduled replacement of hydraulic hoses will be made to help prevent blowouts from old hoses.

**Note:** EE&G will remove floating trash by hand if it can be reached by a rake. The Coast Guard has instructed us not to wade into the water and remove trash or debris but to call them and they will retrieve it. Over the last thirteen (13) years of beach cleaning in Key West EE&G has instituted this policy with the Coast Guard and they have been responsive when we have called.



1.	
2.	During marine turtle nesting season (May 1 to October 31), the permittee is responsible for ensuring that a daily marine turtle nest survey, protection, and monitoring program is conducted throughout the permitted beach cleaning area. Such surveys and associated conservation measures shall be completed after sunrise and prior to the commencement of any mechanical beach cleaning. The marine turtle survey, protection, and monitoring program shall be conducted only by individuals possessing appropriate expertise in the protocol being followed and a valid F.A.C. Rule 68E-1 Permit issued by the Florida Fish & Wildlife Conservation Commission (FFWCC).
3.	All nests left in place shall be marked with a circle of tape or string having a radius of at least three (3) feet, centered at the approximated location of the clutch. An additional marker shall be placed in a landward location to ensure that future location of the nest will be possible should the on-beach markings be lost. No mechanical cleaning equipment shall be allowed to occur inside of this circle. However, careful removal of material by hand shall be allowed. All equipment operators should be briefed on the types of marking utilized and should be able to easily contact the individual responsible for the nest survey to verify any questionable areas.
4.	In the event that mechanical beach cleaning occurs prior to completion of the marine turtle nest survey, protection, and monitoring program, mechanical beach cleaning shall not occur landward of the wrack line on that beach until 65 days have passed or after November 30, whichever is earlier. The permittee shall contact the Marine Turtle Permit Holder prior to reinitiating mechanical beach cleaning in that area.
5.	In the event that on-beach nest markers are lost for any reason, including vandalism or high water conditions, no mechanical beach cleaning shall be conducted until the marine turtle permit holder identifies the nest and restores the markers. In the event that the nest cannot be found and may have been lost during high water conditions, the permittee shall contact the DEP to determine if mechanical beach cleaning can resume. All marine turtle protection conditions shall remain in effect unless specifically waived in writing.
6.	In order to avoid adverse impacts in the event that cleaning accidentally occurs over a nest, this permit authorizes the use of a vehicle with a maximum tire pressure of 10 p.s.i. and a rake or cleaning apparatus, which limits penetration into the surface of the beach to a maximum of two inches. Box blades and front or rear mounted blades are not authorized. No other types of vehicles may be operated on the beach pursuant to this permit. Mechanized beach cleaning shall be accomplished so that no ruts are formed on the beach.
7.	Burial or storage of any debris (biotic or abiotic) collected is prohibited seaward of the 50-foot setback. Removal of accumulated debris from the beach must occur immediately after cleaning has been performed.
8.	Operators of mechanical beach cleaning equipment shall avoid all native, salt tolerant dune vegetation by a minimum of ten (10) feet.





#### G. Seaweed Disposal Plan and Permitted Disposal Site.

EE&G will remove seaweed from Smathers and Rest Beach's by way of a dump truck and deliver it to a Florida Department of Environmental Protection (FDEP) approved trash yard processing facility (ID# 315-06-YT), operated by EE&G on Rockland, Key, MM8, US Highway 1, Florida 33040.

Seaweed, once properly rolled and dried, will be relocated to Toppino and Sons, Inc. fill yard to be recycled with top soil so that it can be used within the local community. Seaweed will not be stock piled by itself, it will be mixed with other soil as mentioned which gives it the appearance of a larger seaweed pile.

This will be the recycling process for the seaweed which is a preferred alternative to disposal in a landfill.

EE&G has held a FDEP Yard Trash Recycling Facility Permit for 13 years at Rockland Key in good standing (see Appendix B) and has no citations or negative reporting's concerning our seaweed recycling process. Upon this award, we will obtain the same FDEP Permit for EE&G.

EE&G continues to encourage sustainability by the reuse of seaweed materials by donating dried seaweed to the City Police Department, City and County Parks, State Parks, local charities, and local landscapers. A substantial amount of dried seaweed is recycled locally. Dried seaweed is always available to the public for mulch upon request and for those in the local community we load at no charge.

EE&G provides the City a Seaweed Report once a month and also provides to the FDEP a report annually of the quantity of seaweed recycled in cubic yards as collected on the beaches.





#### **BEACH CLEANING PERMIT CONDITIONS** WITHIN MONROE COUNTY

Pursuant to subsection 62B-33.005(11), F.A.C.

Field Permit No. 8035201-110

- 1. During the marine turtle-nesting season (May 1 to October 31), mechanical beach cleaning activities shall be confined to daylight hours (sunrise to sunset).
- 2. During marine turtle nesting season (May 1 to October 31), the permittee is responsible for ensuring that a daily marine turtle nest survey, protection, and monitoring program is conducted throughout the permitted beach cleaning area. Such surveys and associated conservation measures shall be completed after sunrise and prior to the commencement of any mechanical beach cleaning. The marine turtle survey, protection, and monitoring program shall be conducted only by individuals possessing appropriate expertise in the protocol being followed and a valid F.A.C. Rule 68E-1 Permit issued by the Florida Fish & Wildlife Conservation Commission (FFWCC).
- 3. All nests left in place shall be marked with a circle of tape or string having a radius of at least three (3) feet, centered at the approximated location of the clutch. An additional marker shall be placed in a landward location to ensure that future location of the nest will be possible should the on-beach markings be lost. No mechanical cleaning equipment shall be allowed to occur inside of this circle. However, careful removal of material by hand shall be allowed. All equipment operators should be briefed on the types of marking utilized and should be able to easily contact the individual responsible for the nest survey to verify any questionable areas.
- 4. In the event that mechanical beach cleaning occurs prior to completion of the marine turtle nest survey, protection, and monitoring program, mechanical beach cleaning shall not occur landward of the wrack line on that beach until 65 days have passed or after November 30, whichever is earlier. The permittee shall contact the Marine Turtle Permit Holder prior to reinitiating mechanical beach cleaning in that area.
- In the event that on-beach nest markers are lost for any reason, including vandalism or high water conditions, no mechanical 5. beach cleaning shall be conducted until the marine turtle permit holder identifies the nest and restores the markers. In the event that the nest cannot be found and may have been lost during high water conditions, the permittee shall contact the DEP to determine if mechanical beach cleaning can resume. All marine turtle protection conditions shall remain in effect unless specifically waived in writing.
- In order to avoid adverse impacts in the event that cleaning accidentally occurs over a nest, this permit authorizes the use of a 6. vehicle with a maximum tire pressure of 10 p.s.i. and a rake or cleaning apparatus, which limits penetration into the surface of the beach to a maximum of two inches. Box blades and front or rear mounted blades are not authorized. No other types of vehicles may be operated on the beach pursuant to this permit. Mechanized beach cleaning shall be accomplished so that no ruts are formed on the beach.
- 7. Burial or storage of any debris (biotic or abiotic) collected is prohibited seaward of the 50-foot setback. Removal of accumulated debris from the beach must occur immediately after cleaning has been performed.
- 8. Operators of mechanical beach cleaning equipment shall avoid all native, salt tolerant dune vegetation by a minimum of ten (10) feet.
