**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, PROVIDING FARE FREE BUS SERVICE FOR CITY BUS ROUTES FOR SENIOR CITIZENS WHO RESIDE IN THE CITY OF KEY WEST; AND FARE FREE BUS SERVICE FOR CITY BUS ROUTES AND THE LOWER KEYS SHUTTLE FOR 100% SERVICE-CONNECTED DISABLED UNITED STATES ARMED FORCES VETERANS; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, senior citizen and 100% Service-Connected Disabled United States Armed Forces Veterans currently pay fare for use of the bus services offered by the City of Key West Department of Transportation; and

WHEREAS, to support and encourage the use of public transportation by City of Key West Senior Citizens, and 100% Service-Connected Disabled United States Armed Forces Veterans the City Commission finds that it would be appropriate to establish a fare free bus service; and

WHEREAS, the City Commission finds it would be appropriate to support 100% Service-Connected United States Armed Forces Veterans by providing free transportation on City Routes as well as the Lower Keys Shuttle; and

NOW, THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, AS FOLLOWS:

Section 1: That a senior citizen may use City Bus Routes at no charge for senior citizens age 60 and older who apply for a Key West Transit Department issued identification card or present proof of age and Key West residence in conformance with policies and procedures established and amended from time to time by the Key West Transit Department

Section 2: That 100% Service-Connected Disabled United States Armed Forces Veterans shall be granted free transportation on City Bus Routes and the Lower Keys Shuttle, in conformance with policies and procedures established and amended from time to time by the Key West Transit Department.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
