

Narrative 1 - SUPPLEMENTAL

On April 1, 2016, Detective M. del Valle and I (Detective J. Dean) met with Detective Lieutenant A. Vazquez, Captain J.R. Torres, and Chief D. Lee, in reference to threatening messages made by a subject, Steven Legnaioli.

Captain Torres played me a recording of a voicemail left at the Commissioners Office at City Hall earlier that morning. In the voicemail, the speaker identifies himself as Steven Legnaioli, and advised that he had been threatened by the Key West Police Department. Legnaioli advised that the Chief, Mayor, and the Commissioner (unspecified which commissioner) were acting in a "criminal manner". Legnaioli goes on to advise that there is one person in particular he feels directly threatened his family and that he may have to "neutralize" that person. Legnaioli does not specify in the voicemail what he meant by "neutralize" or who specifically he was talking about neutralizing.

At that time, I was aware that Legnaioli had made threats against Key West Police Department Officers in the past. Chief Lee advised me that in the past, Legnaioli alleged that he and his wife had been contacted and threatened by Capital Police (out of Washington D.C.) and wanted the Key West Police Department to arrest whoever threatened him. Chief Lee advised that he had attempted to refer Legnaioli to Capital Hill Police Department Internal Affairs, and attempted to explain about the jurisdictional issues that would prevent the Key West Police Department from investigating Legnaioli's allegation. Chief Lee advised Legnaioli refused to accept what he had been told.

Chief Lee advised me to locate and make contact with Legnaioli for the purpose of identifying who ne wanted to "neutralize", and what he meant by "neutralize". Chief Lee also told me to issue Legnaioli a trespass warning for City Hall, and to advise him not to contact anyone at City Hall in reference to the Capital Police issue or he would face criminal charges.

Chief Lee also advised that Legnaioli had recently some how acquired Commissioner Jimmy Weekly's cell phone number and had been contacting him directly.

In the voicemail, Legnaioli identified himself and advised that there were people threatening his family and that he would have to kill a "bunch of people" for those threats. Legnaioli does not specify who he planned to kill in his voicemail to Commissioner Weekly.

I asked Commissioner Weekly if he had any idea who Legnaioli was talking about killing. Commissioner Weekly advised that based on his conversations with Legnaioli, he believed Legnaioli was talking about killing a female Capital Hill Police Officer.

Commisoner Weekly provided me a copy of the voicemail.

A short time later, Detective Sergeant B. Lariz advised that Special Investigations Unit Detectives had located Legnaioli going into his home at 1708 Catherine St. No contact was made with Legnaioli at that time.

Detective M. del Valle and I went to Legnaioli's home and made contact with him without incident. My BWC was activated at that time and recorded my interaction with Legnaioli.

Legnaioli did not advise who he was talking about in either voicemail to City Hall or Commissioner Weekly, but did advised that he felt threatened by a female officer with Capital Hill Police, KWPD Sergeant R. Allen, and KWPD Sergeant R. Smith. During my interview with Legnaioli, he also specifically named KWPD Officer K. Bouvier, KWPD Lieutenant J. Tripp, and KWPD Captain S. Carey was able to forward me the voicemail. In the voicemail, a male voice, advised that he had a question and requested to be called back.

Legnaioli's wife is named Danielle Legnaioli, which is consistent with the name listed on the Caller ID of Carey's phone.

On May 24, 2017, I received another forwarded voicemail from Carey. I recognized the voice in the voicemail as belonging to Legnaioli, who does not identify himself. In the voicemail, Legnaioli claims the Mayor has been lying to him and the State Attorney has confirmed that the Mayor has been conspiring with the Chief of Police. Legnaioli advised he wants whoever is listening to the voicemail to know who they are working for. Legnaioli goes on to advise that whoever receives the voicemail knows who they are working for since they choose to continue going on working there, "we know who you are too". Legnaioli goes on to say "That fucking piece of shit Republican Mayor has been using this office to commit crimes. Extremely fucking crooked. You need to look into this. You need to know who you are working for." Legnaioli goes on to advise "there's gonna be consequences".

Probable cause exists to believe Steven Legnaioli committed the offense of harassing phone calls (F.S.S. 365.16(b)). Steven Legnaioli, left a voicemail on Lissette Carey's work phone. In the voicemail, Legnaoili uses abusive language saying "fucking piece of shit" and "fucking crooked" and threatens Carey by saying "there's gonna be consequences". Legnaoili has a history of making harassing phone calls to city employees and officials and has been warned that doing so would result in criminal charges.

The suspect did knowingly and intentionally commit Harassing Phone Calls to the Florida Statute in such cases made and provided, and against the peace and dignity of the State of Florida.

Dean "Unfortunately we've already had this conversation, you had this conversation with the KWPD, The City Managers office, I understand you don't agree with us"

Me " No , its the law , it's the law"

Dean "But it does not fall under our jurisdiction"

Me "It doesn't?"

Dean "If you continue to call them about this matter, or if you show up there you will be subject to arrest for stalking, harassment, and trespassing"

Me "what can I do about Sargent Allen threatening my family?..you guys took this very seriously, what about us ...what about us?"

Dean "we have our internal affairs, if that didn't work out for you i'm sorry, but thats where we are at with this right now "

Me "Your just shrugging your shoulders cause I hit the blue wall?"

Dean" "I wish there was more I could do for you, I understand you disagree, but it does not fall under our jurisdiction, and thats the position our department has taken"

The Basics of my original compliant.

I received a threatening call from Rand Pauls Communication director on her private phone 9:00 pm, this was in response to me leaving a message at one of his offices.

The next morning I called Capitol Hill Police Threat Assessment Division and told the Agent who answered what had happened the night before, she told me that she got a call from that lady, she told me she never called you and that you repeatedly called and harassed her, I suggested that I pull my phone records and send them to her so she can see who is telling the truth and hold the liar accountable, she said "I don't care what the fuck you records show, she won't be held accountable".. I hung up

My wife then started to receive repeated phone calls on her cell phone at work from the CHP agent , then the secretary at the dentist office where my wife was working started to receive calls from this agent , then the doctor got on the phone and was threatened with arrest for knowing my wife. He was shaken and called his Congressman and CHP to tell them what was happening.

The "staffer" from Rand Pauls office who made a bunch of false claims in my original complaint, confessed to the CHP Agent Zimmeman (mentioned in the complaint) that she DID call me, and Agent Zimmerman said my phone records were no longer needed.

KWPD was called and my original complaint was made, I wanted to press charges for the threatening and harassing calls, as did my wife and her employer.

KWPD told me that they couldn't investigate or make an arrest because the call came from outside their jurisdiction, and I should call the police from where the call was made.

This was told to me by Officer Bouvier, with Zamora verifying 2013

By meeting with officer Bouvier I was expecting to bring a conclusion to this case, but what happened was unexpected. After repeated calls to Bouvier that went unanswered, I contacted Sargent Boutrious who forced the meeting to happen.

Officer Bouvier started the meeting by re-reading the report he made so we could discuss it, and started our discussion by telling me a lie, that the case status was 'other' because it was determined a crime had not been committed.

"Because there was no crime status , there was no crime being investigated , whats the crime you were reporting?" -Bouvier

"What was the threat, cause based on the statute I got nothing" -Bouvier

"How were they threatening you" -Bouvier"

Bouvier had just finished reading his report where I outlined the crimes ... repeated calls where the callers threatened and harassed my wife and I, stating that we were in danger and threatening to 'take us down' ...but still doesn't see a crime that has been committed, and continues to act confused and asks ..

"Whos in danger?" -Bouvier"

"It's in the report you took , she told me I was in danger , she was threatening me on the phone" -Legnaioli

"Your saying it's in the report I took? .. cause I don't see it" -Bouvier

"Began to curse and threaten..." -Legnaioli

"Thats not her it's you" -Bouvier

"'Mr Legnaioli said the staffer called and began to curse and threaten" .."Lets just start on the first sentence, maybe you need to read the report again" -Legnaioli

"Right, maybe I do " -Bouvier

Bouvier has now established that he doesn't have a basic understanding of the complaint I was making. In fact he thinks that the threats made TO me ...were made BY me. He goes on to state that .."I don't remember what I told you 5 years ago"... but fior someone who doesn't remember what was said 5 years ago he now takes a giant leap and states that .. "I made contact with the staffer and Capitol Hill Police, they completely and totally deny what you are saying and in fact said that you were the one that was being aggressive" -Bouvier

5 years later he is now making statements in defense of the perpetrators ...statements that are missing from his report. Statements that cannot be backed up today, and statements meant to excuse his unprofessional behavior while investigating this case ...or it should be said lack of investigating"

Bouvier is claiming both of the callers told him they "completely and totally deny" the accusations ...but for some reason failed to put these denials that are essential to the case in his report. In fact Bouvier never spoke to the CHP agent , but is now making statements for the agent on her behalf. I believe this is criminal behavior.

Bouvier kept repeating his defense that the callers told him they were innocent, and I kept asking where it said that in the report. He couldn't back up his statements.

The fact is that when we met 5 years ago Bouvier told me that the he couldn't investigate the case because it fell outside their jurisdiction, I turned to the Chief of Police for help and asked him to look into the matter and when he got back to me he stated that the case didn't

After meeting with officer Bouvier it was clear that he was confused about the law (365.16) and the specifics of the report he submitted on my case ().

The original excuse for not investigating the complaint was that since the threatening phone call my wife and I recieved was placed from outside their jurisdiction , it then fell outside their jurisdiction to investigate , that I should contact the city from where the call was placed , as it falls under their jurisdiction.

During our recent meeting officer Bouvier stated he did not remember telling me that excuse , and that the real reason he didn't investigate was because no crime was committed because the staffer "denied it happened when I spoke to her" ...and in fact "said the opposite of what you said" ... I repeatedly asked where in his report it says that ... he repeatedly stated that "she told him that when they talked": ..5 years ago. And after many failed attempts to have him point that out in his report he gave up and the sargent started answering questions. The original excuse about "jurisdictional issues" was abandoned and forgotten by Officer Bouvier but not forgotten by the Chief of Police and Detective Dean who continues to back up officer Bouvier's original excuse to this day, as documented in attached incident report. Officer Bouvier displayed his confusion about the report when he attributed my claims of being threatened to her claims of threatened, as shown in attached video and transcript. Also Officer Bouvier repeatedly made claims the staffer denied the accusations I made against her ...but for some reason he failed to put that in his report. Officer Bouvier also refers to a voicemail that he never bothered to listen to....ytet inserted into his report. At the time the complaint was made I also told officer Bouvier that the caller from Capitol Hill Police had also been calling and harassing my wife on her personal cell phone, and also contacting my wifes place of work and repeatedly harassing the secretary and the doctor she works for. I explained to Officer Bouvier that that they could back up the evidence I gave him and that when he interviews them they would like to file a complaint as well. Officer Bojuvier never contacted any of the witnesses, he also never contacted the caller from Capitol Hill Police about the threatening phone calls made to Me, my wife, the secretary and the doctor, and when confronted about the staffers calls he said to me he believed the denial from the staffer and ended his investigation ... a denial he never reported anywhere, in a report, not on bodycam, nowhereand only mentioned 5 years later when Sargent Boutrios ?? made officer Bouvier meet with me after he failed to return my phone calls. At one point officer Bouvier stated that he can't be expected to remember what happened 5 years ago, in the next breath he then states he remembered she "denied" everything", and in fact "said the opposite" of what I said.

fall under their jurisdiction because the call was placed outside KW ...the same excuse that Bouvier gave to me. The samer excuse that the Chief is still using today to try and wrongly prosecute people , as shown in attached text from a current affidavit. I believe this shows criminal behavior on part of the KWPD. The text attached is sworn under oath to have happened , it shows the Chief of police commenting on and explaining the reason he can't investigate my case as a "jurisdictional issue" ...Detective Dean has also latched onto this criminal position , as shown in attached text from his bodycam on (date) ...The Chief and Dean have stated this is not a crime , yet have both conspired to have me arrested for the very same thing they said wasn't a crime.

My wife and I feel that our rights have been violated by the KWPD I want to press charges on Bouvier for his false statements and his denying my wife and I due process.

Meeting with Bouvier

"Why does the status say 'other"

"Because there was no crime status, there was no crime being investigated, whats the crime you were reporting?"

"What was the threat? .. cause based on the statute, Ive got nothing"

"How were they threatening you?"

"You didn't tell me that when we talked"

"When I discuss the issue whith both the agent and the staffer"

"Whos in danger?"

Its in the report you took , she told me I was in danger < she weas threatening me on the phone"

"Yopur saying its in this report I just took? .. cause I don't see it"

"Began to curse and threaten"

"Thats you not her"

"Mr. Legnaioli said the staffer called and began to curse and threaten" .."lets just start on the first sentence, maybe you need to read the report again"

"Right, maybe I do"

So, you made accusations, right"

I made contact with the staffer, as well as CHP, they completly totally deny what your saying and in fact said that you were the one that was being aggressive"

"What is it you want me to do?"

"Thats what you saidf, and she said the exact opposite when I spoke to her"

"Where does it say that, that she said the exact opposite?"

"Those weren't her words"

"Where is it in the report?"



"You said you felt the case didn't fall under your jurisdiction because the call was placed outside you jurisdiction is what you told me"

I don't recall that"

"What do you want"

"I was harrassed and threatened, where does she deny it"

"She didn't neccassarly deny that "

I made an accusation, and you said she denied it"

When I spoke to her , what she told me was \dots ."

"If she told you that it should be in the report, please"

"I don't remember what I told you 5 years ago"

"What in this statute are you saying was violated"

"Where does it say that she denied what I said?"

Complaint on Chief Donald Lee and Detective Jeff Dean

Dean was at my house on April 1st 2016 to inform me that anymore calls made to City Hall concerning my case 01-13-002756 will result in arrest , he informed me that the KWPD position on my case is that it doesn't fall under their jurisdiction , and since I have been informed of this a few times , that any further calls would be seen as harassment , and would result with me being arrested , I told him I disagreed. This is outlined in Deans incident report case 01-16-001359, and shown in bodycam footage)

In June 2017 Dean carried out his illegal threat and had me arrested, he used his flawed interpretation of the law as basis for probable cause to convince a judge to sign a warrant for my arrest, as shown in signed affidavit.

Deans position that since the threatening calls my wife and I recieved didn't come from within KW, that it doesn't fall under their jurisdiction. That jurisdiction fell where the call was placed.

Statute 365.16 does not make this a requirement, and I feel that Dean was acting outside the law and actually making threats of arrest based on a flawed interpretation of 365.16. I tried to explain to Dean how he was wrong and he didn't want to hear of it, this is explained in the incident report and on Deans bodycam footage from my house.

Detective Dean told me, and explained in his report 01-16-001359 that a call coming from outside KW into KW was outside his jurisdiction, then he had me arrested, just like he previously threatened, for placing a call outside KW into KW ...the very thing he said fell outside his authority.

Dean states in his report "Chief Lee advised me that he had attempted to refer Legnaioli to Capitol Hill Police Department Internal Affairs, and attempted to explain about the jurisdictional issues that would prevent the KWPD from investigating Legnaiolis allegation", (01-13-002756) Chief Lee advised that Legnaioli refused to accept what he was told"

Dean also hears me state in the voicemail left at City Hall that ... "The State Attorney office has verified that his case falls inside KW jurisdiction and that the KW Mayor has lied to him"

And just like the times before where Dean was confronted with the jurisdictional issue with my case 01-13-002756 ...he ignores the red flags any Detective would have seen and looked into.

I have spoken to Capitol Hill Police Sarg. Scott Grossi of the Office of Professional Responsibility of the US Capitol, just like IA Sargent Castillo suggested, he can be contacted here 1-202-512-2170, who confirmed jurisdiction fell under KWPD. I have spoke to SA Key West Dennis Ward, who also confirmed jurisdiction falls under KWPD. My family also believes that our constitutional rights have been violated by this action. It is unreasonable to believe that the Chief of Police and Detective Dean didn't know how to determine basic jurisdiction of a caseeven when I repeatedly tried to explain it to them.

I believe that Deans actions were malicious in nature. Dean was at my house to warn me that my calls were criminal, but also took the position that calls made to me were not criminal. I feel he is applying the law unequally, I believe his intent is malicious, and I believe his actions and unlawful legal positions have and will get more people arrested. I feel my rights have been violated, and I feel my family has been targeted by Detective Dean.

I would like to press charges on Detective Jeff Dean for any crimes he committed against me. And if the Chief instructed Dean on this jurisdictional issue, as the affidavit suggests, then it is established that Lee lied to an investigating officer and is in violation of 837.05., then he should be charged as well.

Sargant Castillo looked into a complaint I filed with him against the Chief of Police Donald Lee , the Chief stated my case 01-13-002756 didn't fall under KWPD jurisdiction , as shown in attached complaint, the IA affairs Sarg. Castillo stated he agreed with the Chief , and disagreed with the SA Dennis Ward , and IA of Capitol Hill Police , Sarg. Scott Grossi 1-202-512-2170 and that he was closing the investigation. Castillo can be heard and seen stating this on Sarg. Barrious's body cam footage from 11/7/2018 in the front lobby of KWPD around 12:15, he feels there was no wrong doing and considers the complaint closed. Chief Lee and Detective Dean both knew, and allowed an unlawful position that the State Attorney Dennis Ward instructed them was wrong on May 2nd 2017 to be used in a signed arrest affidavit nearly 2 months later to establish probable cause to arrest me , Legnaioli. I feel this is a violation of Florida law , and violates my Constitutional Rights.
