An application was received requesting the removal of (2) Gumbo Limbos (tree# 5 & 6) and (2) Sea Grape trees (tree# 7 & 9) that are being impacted by the redevelopment of the Regal Cinema Movie Theater which was heavily damaged by Hurricane Irma. A site inspection was done and documented the following:





Tree Species: Gumbo Limbo (Bursera simaruba)

Tree#5:













Diameter: 10.5"

Location: 60% (tree planted under utility lines)

Species: 100% (on protected tree list)

Condition: 70% (fair to good) Total Average Value = 76%

Value x Diameter = 7.9 replacement caliper inches
















Diameter: 14.9" (multi trunked)

Location: 60% (planted under utility lines) Species: 100% (on protected tree list)

Condition: 50% (fair to poor, poor structure, decay in canopy)

Value x Diameter = 10.4 replacement caliper inches





branches)


Total Average Value = 60%

Value x Diameter = 20.4 replacement caliper inches

Diameter: 14.6" (two trunks)

Location: 70% (close to structure)

Species: 100% (on protected tree list)

Condition: 50% (fair, codominant trunks, canopy growth one sided due to

structure, some canopy damage)

Total Average Value = 73%

Value x Diameter = 10.6 replacement caliper inches

Gumbo Limbo #5 = 7.9"

Gumbo Limbo #6 = 10.4"

Sea Grape #7 = 20.4"

Sea Grape #9 = 10.6"

Total replacement requirements 49.3 caliper inches.

Along side of theater, new emergency exit doors and walkways being installed. This work will impact Sea Grape #9 and Sea Grape shrub #13 (both to be removed). Recommend remaining trees on the property be properly trimmed by a certified arborist to correct storm damage and lack of maintenance.




Sea Grape Shrub #13

Sabal Palm on left to remain, Sabal Palm on right to be removed, silver buttonwood shrub and bottle palm also to be removed.


