A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KEY WEST BUSINESS GUILD, INC. TO CONDUCT A PRIDE STREET FAIR ON SATURDAY JUNE 8, 2019 FROM 10:00 A.M. TO 10:00 P.M. (SET UP AT 7:00 AM) ON THE 700 & 800 BLOCKS OF DUVAL STREET AND A PARADE ON SUNDAY JUNE 9, 2019 FROM 5:00 P.M. TO 7:00 P.M. STARTING AT THE TRUMAN WATERFRONT, TAKING A LEFT ON WHITEHEAD, RIGHT ON FRONT AND RIGHT ON DUVAL STREET ENDING ON SOUTH AND DUVAL STREETS; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCES PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE EVENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West Business Guild, Inc. wishes to conduct their annual 2018

Pride Fest Celebration.

NOW, THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That the Key West Business Guild, Inc. is hereby granted permission to conduct a street closure on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Business Guild, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 3. That Key West Business Guild, Inc. is hereby granted permission for the closure of 700 & 800 blocks of Duval Street for a street fair and the closure of certain street for the parade on the date and during the hours stated above.

SECTION 4. That the Key West Business Guild, Inc. is granted a Special Event Permit under section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein describes.

SECTION 5. That the Key West Business Guild, Inc. will adhere to the recycling plan of the City of Key West and that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.
