**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE KEY WEST MERMAID FESTIVAL, INC. TO CONDUCT A MERMAID PARADE ON SATURDAY JULY 6, 2019 FROM 8:00 A.M. TO 11:30 P.M. STARTING AT UPPER DUVAL STREET, GOING DOWN DUVAL, TURNING A LEFT ON FRONT, A LEFT ON WHITEHEAD STREET AND A RIGHT INTO THE TRUMAN WATERFRONT PARK AND A FESTIVAL ON THE GRASSY AREA SURROUNDING THE SPLASH PAD FROM 12:00 P.M. TO 6:00 P.M. AUTHORIZING A PARTY ON SUNDAY, JULY 7, 2019 FROM 11:00 TO 6:00 P.M. AT THE SIMONTON STREET BEACH PARKING LOT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Key West Mermaid Festival, Inc. wishes to conduct the 1<sup>st</sup> annual Key West Mermaid Festival on the date and time stated above.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** That the Key West Mermaid Festival, Inc. is hereby granted permission to conduct a street closure and the use of the Truman Waterfront Grassy area on the date and during the hours stated above; **PROVIDED** all trash is adequately collected and contained; guarantee indemnifying the city is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Mermaid Festival, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** That Key West Mermaid Festival, Inc.. is hereby granted permission for the closure of Duval Street for a parade and the use of the Truman Waterfront for the closure of certain street for the parade on the date and during the hours stated above.

**SECTION 4.** That the Key West Festival Mermaid, Inc. will adhere to the recycling plan of the City of Key West and that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 5.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
