Mr. Bradshaw following up on the additional information the City has requested on the ITB#19-008 CITY OF KEY WEST COMPREHENSIVE CCTV SECURITY SYSTEM ROAD SURVEILLANCE AND MONITORING FOR DUVAL STREET, MALLORY SQUARE & OUTER MOLE. The information requested follows.

- 1. Please provide a complete description of the system proposed and proof that it meets the basic parameters of the system required.
 - IFSS understands the system requirements and as designed for the City by Avigilon and Siklu as the most significant roles in the overall system operation.
 - IFSS is attaching exhibit 'A" which is the Siklu/IFSS designed for the wireless radio/relays that has been proposed and will be installed as part of the CCTV project.
- 2. Please provide proof of that you meet the following REQUIRED QUALIFICATIONS.
 - The prospective Bidder must meet the statutorily prescribed requirements before award of Contract by the CITY. Bidders must hold or obtain all licenses and/or certificates as required by the State and Local Statutes in order to bid and provide the product specified herein.
 - I. IFSS EC Unlimited license is attached as Exhibit "B".
 - Bidder must have experience with outdoor municipal long-range wireless deployments of over 2 miles and have deployed mesh network systems in a public safety environment. This should include Point to Point, Point to Multi Point, and Mesh networks.



- a. IFSS experience in system installation using the proposed solution include several projects. The following is a list of similar projects.
- b. City of Miami Down Town CCTV surveillance project. IFSS installed 16 cameras throughout the City of Miami Biscayne Blvd area from SE 1st Street to NW 14th Street utilizing mesh and point to point wireless antennas and several PTZ and Fixed Cameras. Miami Airlines Arena served as the main aggregation point for the Biscayne Blvd mesh and all camera views were re-transmitted to City of Miami Police Head Quarters located on NW 2nd Ave and 5th Street. - Bidder must have experience in the installation of PTZ cameras, fixed cameras, radio antennas and weatherproof equipment boxes on City or County traffic poles and Electric Company power poles. Installation is defined as the mounting of PTZ cameras, fixed cameras, radio antennas and weatherproof equipment boxes on City or County traffic poles and Electric Company power poles and connecting them to a power source and providing live and recorded video to a remote location via radio wireless system, with backup by cellular, and uplink by fiber-optic cable.



IFSS per specifications shall be installing the proposed redundent siklu p2p ring. Starting from the Fire Station located on Simington St circling around to the outer mole, Mallory Square and down Duval St returning back to the fire station with Axis cameras to be installed at specified locations. All power supplies shall be the PPU-1 with the PPU-POE at each location a device is installed. Except at the outer mole where there shall be (1) PPU-1 installed with (2) PPU-PDE at the city shall supply high voltage on the poles to a service weatherhead supplied and installed by IFSS. All fasteners used on poles shall be stainless steel banding. City shall provide the Network switch and fiber run between the Fire Station and city hall where all the headend Avigilon equipment shall be installed in the rack supplied by the city and plugged into the City's UPS located in rack. City shall also provide a fiber connection from city hall to the police station with a network switch at the police station. IFSS will then install a workstation. (2) 32" 4% samsung monitors and the Avigilon PTZ Joystick at the Police so they can monitor it from there.


