A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RESCINDING RESOLUTION NO. 18-122 FOR PURCHASE OF ONE FORD F250 XL FROM KEYS AUTO SALES; AUTHORIZING THE PURCHASE OF ONE (1) FORD F-250XL 4WD DIESEL 4-DOOR CREW CAB IN A TOTAL AMOUNT NOT TO EXCEED \$42,048.00 FROM DUVAL FORD FLEET SALES, THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA18-VEL26.0 CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE POLICE DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 18-122 the purchase of a Ford F250XL was authorized from Keys Auto Sales, however the vehicle was not delivered, and accordingly the order has been cancelled. Resolution 18-122 must be rescinded so that funds encumbered for the purchase can be released to be used for the purchase of a substantially identical truck from Duval Ford; and

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA18-VEL26.0, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Resolution No. 18-122 for the purchase of an F-250XL Truck from Keys Auto Sales, is hereby rescinded.

Section 2: That the purchase of one (1) Ford F-250XL 4WD Diesel 4-Door Crew Cab, as described in the attached proposal of Duval Ford Fleet Sales, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties Bid No. FSA18-VEL26.0 Contract, in an amount not to exceed \$42,048.00, is hereby authorized for use by the Police Department.

Section 3: That funds for this purchase are budgeted in FY 17/18 under account number 101-2101-521-6400 (Infrastructure Surtax/Police Department/Machinery & Equipment).

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
