• Started installation of the ballot bins. Salty Angler, The Green Room. Coming Soon Mellow Ventures and 801.

School recycling

- All is going well. HOB middle school started last week.
 - Set up recycling station
 - Pour out liquids so cartons can be recycled
 - Scrape off trays and stack trays. We are talking about alternatives to Styrofoam, but for now stacking the trays so they take up less room in the dumpster.
 - Collecting aluminum cans. Hopefully Dan's Cans.
 - Looking to switch schools from plastic cutlery to wooden spork

Single Use Plastic Ban

- We are in a wait pattern.
- On hold. We were moving forward to ban on City property etc. Asked to hold because a judgement is in on the Coral Gables case. If it is in Coral Gables favor we will move forward with a City-Wide ban.
- The case number is 3D-17-562. It appears that oral argument took place in December. A final opinion is likely in the works.

Southeast Recycling Conference

• Focus was on clean recycling. Hard look at processors and collection programs.

Upcoming bills in the Florida legislature

- SB 816 Recycling Improvement Legislation. Bill requiring certain points be addressed in contracts.
- SB 88 Repeal the plastic bag ban
- HB 6033 Preemption of Recyclable and Polystyrene materials Removes preemptions of local law relating to regulation of auxiliary containers, wrappings, or disposable plastic bags; repeals preemption of local laws regarding use or sale of polystyrene products to DACS.
- SB 502 Prohibition of Plastic Carryout Bags and Straws. Prohibition of Plastic Carryout Bags and Straws; Prohibiting a store or food service business from providing a carryout bag made of plastic film to a customer; prohibiting a food service business from selling or providing a single-use plastic straw to a customer, etc.
- SB 588 Single use Plastic Straws. Preemption of Local Regulations; Prohibiting local government entities from adopting or enforcing local ordinances or regulations relating to single-use plastic straws before a specified date; requiring the Department of Environmental Protection, or an entity designated by the department, to conduct a study evaluating the environmental impact of single-use plastic straws; providing penalties for violations of the moratorium by a local government entity; preempting the regulation of over-the-counter proprietary drugs or cosmetics to the state, etc.
- SB 672 Beverage Container Deposit. Bottle Bill.

• <u>House Bill 157</u>: Fertilizers

GENERAL BILL by Thompson

Fertilizers; Requires county & municipal governments to adopt & enforce Model Ordinance for Florida-Friendly Fertilizer Use on Urban Landscapes; specifies that county & municipal governments must require use of specified slow-release fertilizers; provides additional requirements for counties & municipalities within estuary runoff areas; authorizes county & municipal governments to adopt additional standards if certain criteria are met.

• <u>House Bill 405</u>: St. Johns River Upper Basin Watershed Pollutant Control Program GENERAL BILL by Grall

St. Johns River Upper Basin Watershed Pollutant Control Program; Provides that St. Johns River Upper Basin Watershed Pollutant Control Program consists of St. Johns River Upper Basin Watershed Basin Management Action Plan; requires implementation of specified regulations, best management practices, & alternative technologies for pollutant reduction; provides that certain projects are eligible for grants; requires plan to include certain assessments & recommendations; prohibits DEP from authorizing disposal of domestic wastewater biosolids within watershed; directs DOH to require certain entities to develop & submit agricultural use plans; direct DACS & St. Johns River Water Management District to initiate specified rulemaking.
