A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING BAUER RESTAURANT, INC. DBA KEY WEST SONGWRITERS FESTIVAL FOR A STREET CLOSURE AND THE USE OF THE TRUMAN WATERFRONT AMPHITHEATRE STARTING WITH A FREE STREET CONCERT ON THE 100 AND 200 BLOCK OF DUVAL STREET AND GREENE STREET BETWEEN FITZPATRICK & ANN STREETS ON MAY 11, 2019 FROM 5:00 P.M. TO MIDNIGHT(SET UP AT 6:00 A.M.) AND A CONCERT AT THE TRUMAN WATERFRONT AMPHITHEATRE ON SUNDAY, MAY 12, 2019 FROM 5:00 P.M. TO 10:00 P.M.(SET UP STARTING AT 6:00 A.M.);GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FOR A CONCERT ON THE 100 & 200 BLOCK OF DUVAL STREET FROM 6:00 A.M. TO 10:30 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES ON SUNDAY, MAY 12, 2019 WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Bauer Restaurant, Inc. dba Key West Songwriters Festival wishes to conduct a street closure for a free concert on the 100 & 200 block of Duval Street between Duval & Greene Street & Between Fitzpatrick and Ann Street and a Concert at the Truman Waterfront Amphitheatre between the hours of 5:00 p.m. to 10:00 p.m. (set up starting at 6:00 a.m.). on Sunday, May 12, 2019; and

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. Bauer Restaurant, Inc. dba the Key West Songwriters Festival is hereby granted permission to conduct a concert on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, Bauer Restaurant, Inc. dba the Key West Songwriters Festival is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area at the Truman Waterfront on Sunday, May 12, 2019.

SECTION 3. Bauer Restaurant, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash container will be used and that they will be placed side by side.

SECTION 4. Bauer Restaurant, Inc. dba Key West Songwriters Festival is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

SECTION 5. Bauer Restaurant, Inc dba Key West Songwriters Festival will be responsible for the rental fee of Five Thousand (5,000) plus tax and an additional one (1) dollar per ticket sales as well as any other cost associated with the event including payment to Key West Police Department, Key West Fire Department and Key West Community Services.

SECTION 6. Bauer Restaurant, Inc. dba Key West Songwriters Festival must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

SECTION 7. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
