A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE KEY WEST ART & HISTORICAL SOCIETY, INC. TO CONDUCT THE PAPIO KINETIC PARADE & CONCERT AT THE TRUMAN WATERFRONT AMPHITHEATRE ON SATURDAY, MAY 4, 2019 FROM 12:00 P.M. TO 3:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY CITY MANAGER; THE AUTHORIZING THE SALE AND CONSUMPTION ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West Art & Historical Society, Inc. wishes to conduct a "Papio Kinetic Parade and concert" at Truman Waterfront Amphitheatre between the hours of 12:00 p.m. to 3:00 p.m. on Saturday, May 4, 2019; and

WHEREAS, this event shall take place starting in front of the Customs House with a parade and ending on the grounds of the Truman Waterfront Amphitheatre between the hours of 12:00 p.m. to 3:00 p.m. on May 4, 2019.

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That the Key West Art & Historical Society, Inc. is hereby granted permission to conduct their an event on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Art & Historical Society, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 3. the Key West Art & Historical Society, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used that and that they will be placed side by side.

SECTION 4. the Key West Art & Historical, Inc. will be responsible for the rental fee of Five Hundred dollars (500.00), as well as any other cost associated with the event.

SECTION 5. the Key West Art & Historical Inc. must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
