A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TWO-YEAR EXTENSION OF THE CONTRACT AWARDED PURSUANT TO RESOLUTION NO. 16-008 BETWEEN THE CITY AND SEAMAR DIVERS, INC. IN RESPONSE TO ITB #001-16 (TWO INSPECTIONS AT \$7,547.59 EACH PER YEAR); AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS, UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West operates a mooring field where there is a need for inspections of up to 149 permitted mooring systems on a regular basis, and/or when severe weather or other marine incidents may affect the integrity of the mooring systems; and

WHEREAS, in Resolution No. 16-008, the City Commission awarded a three-year contract with an option to renew for two additional years; and

WHEREAS, City staff recommends approval of the two-year extension of the contract, with a negotiated price adjustment.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the contract between Seamar Divers, Inc. and the City of Key West for mooring field inspections, is hereby extended for a period of two years, at a negotiated price of \$7,547.59 per inspection.

Section 2: That the City Manager is authorized to execute necessary documents to effectuate the contract extension, upon advice and consent of the City Attorney.

Section 3: Adequate funding for inspection services is budgeted in Other Contractual Services Account No. 413-7554-575-3400.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
