A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF SEAMAR DIVERS, INC. IN RESPONSE TO ITB #001-16 IN THE AMOUNT OF \$13,722.90 PER YEAR FOR MOORING FIELD INSPECTIONS (TWO INSPECTIONS AT \$6,861.45 PER YEAR); AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN ITB #001-16, UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West operates a mooring field where there is a need for inspections of up to 149 permitted mooring systems on a regular basis, and/or when severe weather or other marine incidents may affect the integrity of the mooring systems; and

WHEREAS, Seamar Divers, LLC submitted the lowest responsive bid in response to ITB #001-16;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Seamar Divers, Inc. in response to ITB #001-16 for mooring field inspections, is hereby awarded at a price of \$13,722.90 per year (\$6,861.45 per inspection), for a contract term of three years with up to two(2) two-year renewals.

Section 2: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained in ITB #001-16, upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.

ACTION STATEMENT:

Resolution approving the low bidder, Seamar Divers, LLC, for the Key West Mooring Field Inspection/Replacement and authorizing the City Manager to execute a three (3) year contract, subject to City Attorney review, in the amount of \$13,722.90 per year.

BACKGROUND:

Key West Mooring Field is comprised of 149 mooring ground tackle rigs that are in place for customers who have the desire to moor their vessels without utilizing conventional anchoring. The mooring field caters to locals and visitors alike and provides a safe and environmentally conscience way to use near shore resources with least amount of impact on the environment. Mooring field inspections have been occurring within the mooring field since its inception, these inspections help keep the infrastructure in good working order and are vital in minimizing mooring field rig failure while in use. Typically the City Marina conducts two of these inspections annually.

PURPOSE & JUSTIFICATION:

ITB #001-16 Key West Mooring Field Inspection/Replacement was publicly advertised and proposals received by three vendors on November 25, 2015. The bids were to include pricing for bi-annual inspection of 149 mooring ground tackle rigs and replacement of complete rigging, with City supplied rigging, as needed.

All three vendors were deemed responsive to the Invitation to Bid providing all required documentation, submittal requirements and provided the following pricing:

Seamar Divers, LLC

\$13,722.90/yr (\$6,861.45 per inspection)

Underwater Mechanix Services, LLC

\$13,857.00/yr (\$6,928.50 per inspection)

Earthtech Enterprises, Inc.

\$27,800.00/yr (\$13,900 per inspection)

Key to the Caribbean - Average yearly temperature 77° F.

ECULAR SUMMA

Staff found a discrepancy in Seamar Divers, LLC bid where the unit price did not calculate to the inspection price. Seamar was contact by email for clarification on their inspection price and confirmed \$6,861.45 to be the correct amount. This discrepancy was not a factor in determining low bidder.

Seamar Divers, LLC has, in the past, been awarded contracts for mooring field inspection providing great service that reflects on a low failure rate of equipment in Key West Mooring Field.

OPTIONS:

Option#1- Approve the low bidder, Seamar Divers, LLC, for the Key West Mooring Field Inspection/Replacement and authorizing the City Manager to execute a three (3) year contract in the amount of \$13,722.90/year.

Option #2 - Reject all proposals

FINANCIAL IMPACT:

The City Marina budgeted for this project in account 413-7554-575-3400 Mooring Field Inspections. Upon approval, a purchase order will be issued to Seamar Divers, LLC, in the amount of \$13,673.70. With subsequent purchase orders issued in the amount of \$13,722.90/yr for the contract duration.

RECOMMENDATION:

Staff recommends approving the low bidder. Seamar Divers, LLC, for the Key West Mooring Field Inspection/Replacement and authorizing the City Manager to execute a three (3) year contract in the amount of \$13,722.90/year.

In consideration of the performance of the work as set forth in these Contract Documents, the Owner agrees to pay to the Contractor the amount bid in the Bid as adjusted in accordance with the Contract Documents, or as otherwise herein provided, and to make such payments in the manner and at the

times provided in the Contract Documents.

The term of this contract is three (3) years with the requirement of two (2) inspections per year. The contract may be extended for two (2) year terms upon terms and conditions agreed to by both parties.

The Contractor agrees to complete the work for each six (6) month inspection within thirty (30) days and to accept as full payment hereunder the amounts computed as determined by the Contract Documents and based on the said BID.

The Contractor agrees to remedy all defects appearing in the work or developing in the materials furnished and the workmanship performed under this Contract during the warranty period after the date of final acceptance of the work by the Owner, and further agrees to indemnify and save the Owner harmless from any costs encountered in remedying such defects.

It is agreed that the Contract, based upon the BID, shall be fully complete within the stated number of consecutive calendar days from the date the Notice to Proceed is issued.

In the event the Contractor fails to complete the work within the time limit or extended time limit agreed upon, as more particularly set forth in the Contract Documents, liquidated damages shall be paid at a rate of \$100.00 per day. Sundays and legal holidays shall be included in determining days in default.

This contract will automatically expire upon completion of the project. Contractors warranty obligations remain in effect.
