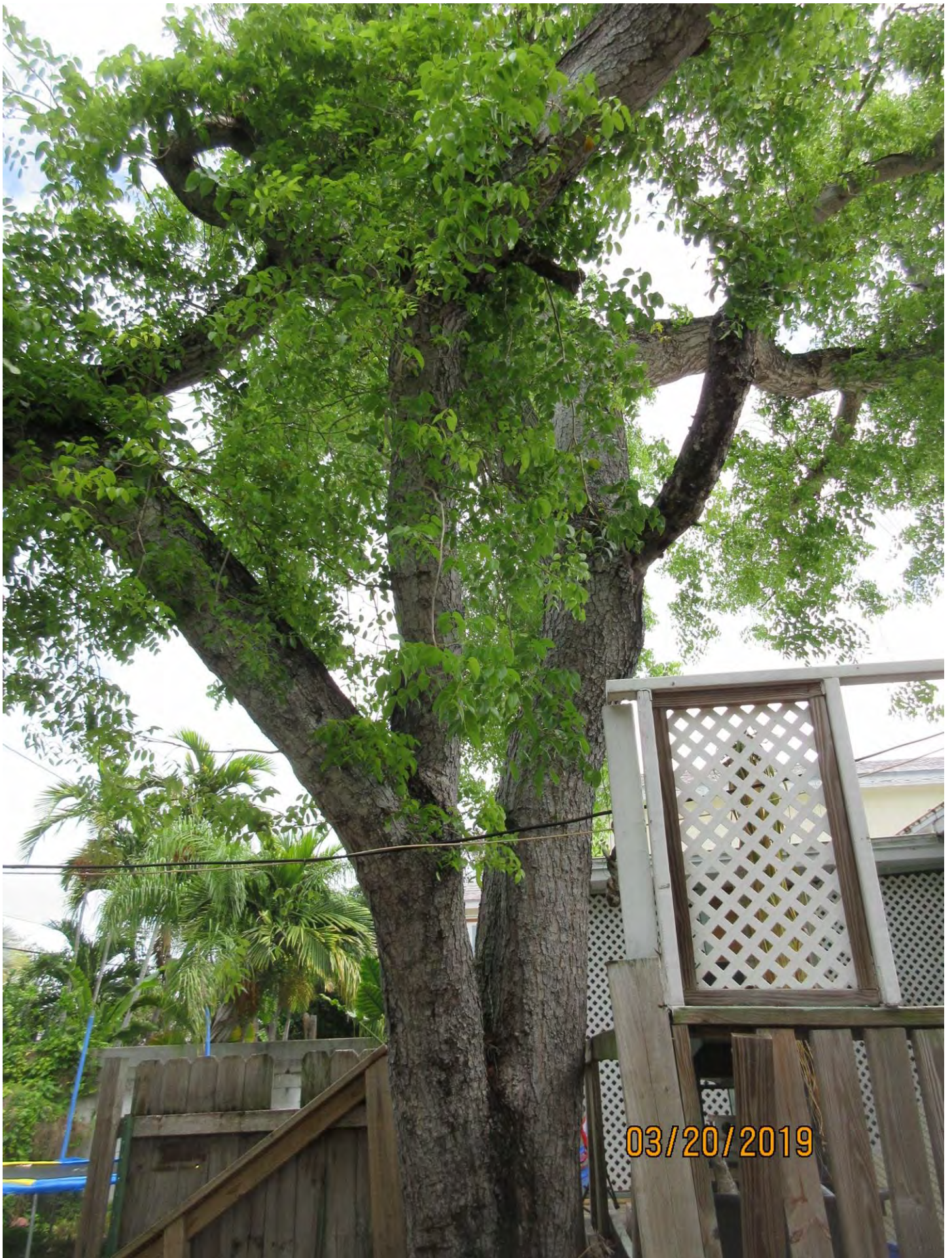

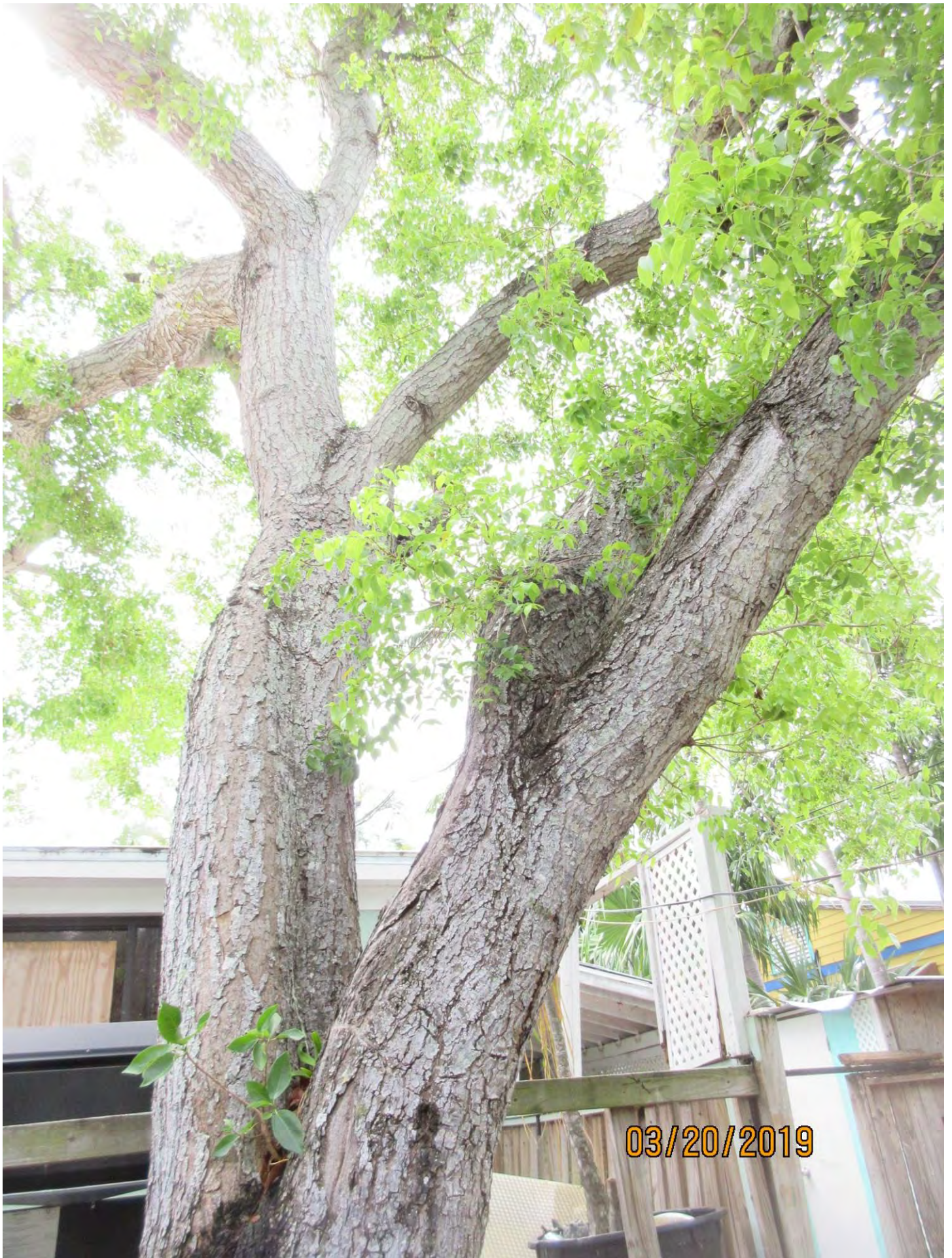

Location: 40% (tree impacting deck, canopy in electrical lines, backyard tree)

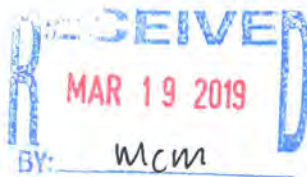
Species: 100% (on protected tree list)

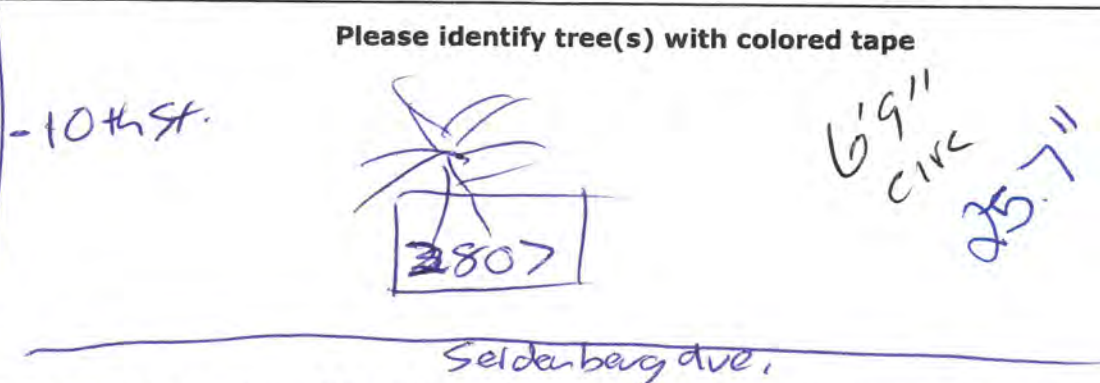
