- **Health Foundation Grant:** Possible funding for projects within the Bike Ped Master Plan. Met Exec Dir 3/7. Due in June.

Other

- **Cisterns:** BPAS Cistern Prerequisite was approved for downgrade by Planning Board. Although all sides had said they'd be amenable to an "escape clause" such as a max cap or waiver.
- **FKAA:** Update from Julie Cheon. Per capita water use has spiked. Turkey Point has additional legal challenges to salt water plume issues. She will present to SAB in April for Water Conservation Month.
- **Affordable Housing:** Need to work on transportation recommendations.
- **Water Quality:** "Reef Safe" Sunscreen: Passed! Meeting with partners to summarize research and organize outreach and education for businesses. Booth at Spring Break. Possible seat for City on Sanctuary Advisory Board. Checking to see if we can count it as HHW.
- **Composting:** New Earth Tub motor installed and composting began, then tore up the electronics. Need to schedule repairs.
- **Last Stand:** Helped identify potential new board members.
