On February 27th, 2019 at 0214 hours, I Ofc. Cuneo was at a steady red light at the intersection of Truman Ave. and Jose Marti Dr. I was facing north on Jose Marti. I observed a white male on a scooter on Eisenhower Dr. traveling south, with no headlight. Once the light changed to green, I went through the intersection and placed my vehicle behind the scooter. I activated my rear facing lights to direct traffic away from the rear of my patrol vehicle. The male had pulled over to the right side of Eisenhower where another male was telling him about the light.

I exited my vehicle and approached the male. I ran the scooter plate which displayed Florida registration MEBA47. I asked the male if his scooter light was not working. He stated the display lights were working but not the headlight. I asked the male for his identification. He stated, "No". I then asked the male if he had a license and he stated, "Yes". I asked the male for his name and he stated, "Dave Matthews" and he gave me a date of birth of 08/03/1982. I wrote all of this down in my notebook I had in hand. The male had stated he had just talked to a cop about getting a Florida ID. When I asked the male where his ID was out of, he stated, "New Hampshire". I returned to my vehicle.

As I returned to my vehicle, Ofc. M Hansell arrived on scene. I exited my vehicle to ask Ofc. Hansell to go and check on the male that had walked away from the scene. I turned around and observed the male flee on his scooter, making a right (west) on Truman.

I then activated my over head emergency lights and followed the male at a safe speed. The male made a right (north) on Pearl St. followed by a left turn (west) on Albury St. I observed the male drive into a property at 1414 Albury St. I observed the male hiding next to where the scooter was laying. I gave loud command for the male to show me his hands. I did have my service pistol drawn at this point.

The male then took off on foot up Albury St. (west). I then holstered my service pistol and fired at the male with my Taser. The taser was ineffective and the foot chase continued west on Albury St. the male then took a right (north) on Florida St. During the chase, I was able to turn off the Taser, take off the spent cartridge and reload with a second cartridge. We continued to run down (north) Florida St.

I gave three loud, "Taser, Taser, Taser" commands at which point the male fell. As I was catching up to him, he began to get up. I then fired the second cartridge at the male, striking him and letting the cycle of five (5) seconds run. The male fell back down and screamed. I gave loud commands for the male to show me his hands. At this point Sgt. Dean arrived on scene to assist. Attempting to gain control of his hands, Sgt. Dean grabbed the male by his right arm and his back and placed him on the street, face first. The male attempted to get up by placing both of his hands on the ground and pushed off the ground. Again, Sgt. Dean attempted to get control of the male's arm and hands. Louder commands were shouted by me to the male to show us his hands.

Both Sgt. Dean and I instructed the male to place his arms behind his back. I was able to grab the male's left arm and place it behind his back, however; I still had control of my Taser in my right hand. Sgt. Dean gave a command to the male to place his right hand behind his back, the male stated, "NO"! The male continued to resist, and Sgt Dean instructed me to run the Taser cycle again. I then ran the Taser another cycle of 5 seconds. At this point the male complied. Sgt. Dean placed handcuffs on the male. Sgt. Dean then informed Key West Police COM 1 the male was in custody. I was able to see a pocket knife in the male's right pocket. I then secured the knife away from the male.

I then searched the male's right pocket, yielding negative results. Sgt. Dean took pictures of the male as he sat in the street. As Sgt. Dean searched the male, a baggie of a white powdery substance was in the male's left pocket. Also found in the males left pocket, was a class vile that had been broken. Sgt Dean had later, field tested the white

powdery substance and the glass vile. Both tested positive for cocaine. The powder`s weight measured 1.2 grams.

Rescue was then called to the scene. They transported the male to Lower Keys Medical Center (LKMC).

While at LKMC I identified the male as Joshua Lee Wells. Once Wells was medically cleared, he was transported to Monroe County Detention center.

Based on the following I believe there to be probable cause for the following charges:

Possession of Cocaine (893.13.6a) Wells had in possession Cocaine, that when field tested, came back positive.

Possession of Drug paraphilia (893.145) Wells did have in his possession a glass vile, used to smoke and snort narcotics and there was cocaine residue on the vile, field testing positive for cocaine.

Fleeing or attempting to elude a law enforcement officer (316.1935-2) Wells willfully fled the traffic stop and attempted to elude my authorized law enforcement patrol vehicle, equipped with the Key West Police Department`s insignia and other jurisdictional markings prominently displayed on the vehicle, with siren and lights activated

Resisting officer without violence (843.02) Wells did resist arrest by running away after I, a certified Florida Police Officer, working for the City of Key West Police Department gave him commands to stop running in the course of my legal duties and without Wells using violence to resist arrest.

Prohibition against giving false name or false identification by person arrested or lawfully detained (901.36-1) Wells did inform me his name was Dave Matthews with a date of birth of 08/03/1982 prior to me finding out his real name.

Driving while license suspended, revoked, canceled, or disqualified (322.34.5) Wells, with knowledge was driving around a scooter, with a suspended New Hampshire driver`s license. Wells has knowledge of this suspension since on 02/04/2019 he was arrested (Pine St., Key West, Fl, County of Monroe). Wells continues to violate this section by driving with a suspended license and making him a habitual offender.

BWC and COBAN system were activated.

I placed all items, except the crack in the evidence locker after they were logged and packaged. The crack was placed and logged by Ofc. Gillespie. It shall also be noted, I advised Wells of his Miranda rights on BWC and he stated he would talk to officers. I asked Wells, at LKMC if the white powder was and he replied, "It`s fake".

On 02-27-2019, I, K-9 Ofc. Matthew Hansell of the key West Police Department, responded to a traffic stop conducted by Ofc. Cuneo at Eisenhower Dr. and Truman Ave.

As I pulled up on scene, Ofc. Cuneo approached my vehicle at which point, the driver of the scooter Joshua Wells, fled on his scooter.

Ofc. Cuneo followed Wells as I went back West on Truman in an attempt to keep him from coming back out onto Truman Ave.

Ofc. Cuneo eventually placed Wells into custody and I went to 1414 Aubury St. to tow the scooter Wells was riding. As I got closer to the scooter, I could see that it was still running and in gear with no key.

There was no gas cap and the scooter was leaking gasoline onto the driveway of 1414 Aubury St.

I stood the scooter up in order to try ad shut it off and prevent more gas from leaking when it lunged forward and struck three medium size pottery planters causing damage.

I notified Sgt. Dean of the damage to the pottery planters and took photos.

I attempted to make contact with the property owner but was unable to at this time.

My Axon body cam was on for this incident.

On February 27, 2019, I (Sergeant J. Dean) responded to the area of the intersection of Petronia St and Florida St, in reference to providing backup to Officer E. Cuneo who was in a foot pursuit. As I entered the intersection in my patrol vehicle, I observed Officer Cuneo chasing a male subject, later identified as Joshua Wells. Wells was running north on Florida St approaching Petronia St. I observed Officer Cuneo discharge his Taser at Wells. The Taser was effective and Wells fell to the ground.

As I got out of my vehicle, I heard Officer Cuneo giving loud verbal commands to Wells to put his hands behind his back. Wells was not following Officer Cuneo's verbal commands and appeared to be attempting to stand up. I grabbed Wells and stopped him from rising. Wells immediately began to pull away from me and repeatedly attempted to bring his arms to his chest, so that I could not handcuff him. I gave Wells a loud verbal command to stop resisting. Wells responded and told me he was not resisting. I gave Wells a loud verbal command to place his hands behind his back. Wells responded by yelling "No!". I advised Officer Cuneo to Taser Wells again. Officer Cuneo delivered a second cycle to Wells from his Taser. Wells immediately complied and placed his hands behind his back. Officer Cuneo and I secured Wells into handcuffs.

Upon a search incident to arrest, I located a broken glass pipe with field tested positive cocaine residue, as well as a small clear plastic baggy with several small pieces of a white rock-like substance, which I recognized as crack cocaine and later field tested (positive).

The pipe was too damaged to submit into evidence as it was mostly broken glass at that point. I photographed its remnants and discarded it. I handed over the FTP crack cocaine to Officer A. Gillespie, who weighed it and submitted it to evidence with a request to have it sent to FDLE labs for analysis.

I photographed Wells' injuries (submitted into Evidence.com) and called for an ambulance upon his request.

At the time of this incident, Officer Cuneo and I were both wearing our KWPD Class B Uniform.

My BWC was activated late during the event. However, Officer Cuneo's BWC captured my entire involvement in the call.
