A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING PURCHASE OF TWELVE (12)**VICTOR** STANLEY SD-42 TRASH AND RECYCLING RECEPTACLES FROM VICTOR STANLEY ON A SOLE SOURCE BASIS PURSUANT TO SECTION 2-797 (4) AND 2-797(1) FOR BRAND NAME ITEMS IN ACCORDANCE WITH 2-844 OF THE CODE OF ORDINANCES IN AN AMOUNT NOT TO EXCEED \$29,618.20, AS DESCRIBED IN THE ATTACHED EXECUTIVE SUMMARY; AUTHORIZING NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS CONSENT OF THE CITY ATTORNEY: PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, Victor Stanley is the only source City staff identified for the purchase of Victor Stanley SD-42 Trash and Recycling Receptacles, which staff has determined to be the most durable and appropriate swinging door outdoor receptacles for use in the historic district; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of twelve (12) Victor Stanley SD-42 Trash and Recycling Receptacles from Victor Stanley, in an amount not to exceed \$29,618.20 is hereby approved, pursuant to Sections 2-797(4) and 2-797(1), in accordance with Section 2-844, of the code of ordinances.

Section 2: That a transfer from Solid Waste fund 403 reserves to account 403-3404-534-4600 is hereby authorized for this purchase.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
