A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED PUBLIC TRANSPORTATION AGREEMENT (PTGA) FM 445630-1-94-01 FOR FY 2019 BETWEEN THE FLORIDA DEPARTMENT TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR THE TRUMAN ANNEX ACCESS AND FACILITY IMPROVEMENTS INITIATIVE PROJECT IN AN AMOUNT TO EXCEED \$200,000.00 (CITY \$200,000.00, FOR A TOTAL PROJECT COST OF \$400,000.00); AUTHORIZING NECESSARY BUDGET AMENDMENTS AND TRANSFERS TO ACCEPT THE GRANT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE PTGA AND RELATED DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the attached PTGA will assist the City with funding the construction of a new access gate facility to allow for two-way traffic, and two pavilions to provide shelter for waiting cruise passengers; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached PTGA (#FM 445630-1-94-01) for funding for the Truman Annex Access and Facility Improvements Initiative Project between FDOT and the City is hereby approved in an amount of up to \$200,000.00, with a City Match of \$200,000.00, for a total project cost of \$400,000.00.

That project expenses of \$400,000.00 will be budgeted in Infrastructure Surtax/Port Operations/Infrastructure account No. 101-4302-543-6300/(Project Number to be determined). Grant revenue of up to \$200,000.00 will be budgeted in Infrastructure Surtax/Revenue/Other State Grant account No. 101-0000-334-9000/(Project Number to be determined), and City Matching funds will be budgeted in Infrastructure Surtax/Port Operations/Infrastructure, Expense Account 101-4302-543-6300/(Project Number to be determined). Any necessary budget adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute the PTGA and related documents, upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
