NOTICE OF APPEAL OF DECISION OF PLANNING DIRECTOR

NOTICE IS GIVEN that FERNANDY'S CAFÉ, LLC files an appeal of the Decision of the Planning Director, pursuant to Key West City Code Chapter 54 and sates:

- 1. On December 21, 2018, the Office of Code Compliance issued a Notice of Code Violation (Case#CC2018-01867), advising that the restaurant had more seats than licensed. The Notice instructed Fernandy's Café, LLC (Petitioner) to contact the Planning Department to get approval for the seats in excess of the exiting license.
- 2. In response, on April 5, 2019, a request for recognition of a Preexisting, Impact-Fee Related Activity with the Planning Director, requesting that his office recognize the pre-existing use of between 26 and 74 seat restaurant located at 1110 White Street (Fernandy's Café is located at the site of the iconic and historic Key West restaurant "Fourh of July"). A copy of the Request is attached as Exhibit A.
- 3. With the request, Fernandy's Café, LLC submitted the following



exhibits (Exhibit numbers appearing on the documents represent the exhibit number from the request, not from this Appeal):

- a. a Monroe County Property Appraisers Card from 1972-74 showing the pre-existence of a restaurant at that location, issued to Berena Caballo, attached as Exhibit B,
- b. The 1984 City Directory for the City of Key West, showing the pre-existence of a restaurant at that location, named Fourth of July, owned by Berena Caballo, attached as Exhibit C.
- c. The County Occupational license from 1985-86 showing the restaurant named Fourth of July, owned by Berena Caballo and located at 1110 White St. was licensed for 74 seats, attached as Exhibit D.
- d. Affidavits from Alferd Altuve, Louis Condos, Tom Sawyer, Betty Jo Williams and Lori Thompson all of whom swore that they were familiar with the 4th of July restaurant and that it had approximately 25 seats (Lori Thompson specified in her affidavit that the seating goes back to the 1970's), attached collectively as Exhibit E.
- 4. The purpose of the impact fee is to compensate the City for the increased service demand that new service will have over a pre-existing

service (See Code Section 54-124 "In estimating the increased demand caused by any solid waste generating activity, the city manager shall estimate the demand of any preexisting activity according to the table referred to in section 54-118 unless actual measurements of usage are available. Preexisting activity includes activity that was taking place on the property on December 4, 1984, or activity that commenced after December 4, 1984, and for which impact fees were paid pursuant to this division. Proof of preexisting land use may be established by official city, county, or state records and licenses, affidavits and photographs. The planning official is charged with the responsibility of determining whether a preexisting land use qualifies under this division. Any person aggrieved by the decision of the planning official may appeal that decision to the city commission by filing a notice with the city clerk within ten days."

- 5. The City Planner has stated that there are no actual numbers from which he can derive the actual use, therefore under the City Code, the City SHALL estimate the preexisting activity.
- 6. Under Chapter 54 of the City Code, when actual numbers are not available, the City can look to "official city, county, or state records and licenses, affidavits and photographs" (Sec. 54-82 and 54-124).
- 7. On May 15, 2019, the City Planner, Patrick Wright, issued his ruling



refusing to recognize the pre-existing activity, ignoring the evidence presented to him and relying merely on the fact that in his opinion the consumption area is too small to support 74 seats (the number of seats stated on the 1985-86 County license). His ruling is attached as Exhibit F. According to his refusal, his decision is solely based on his observations of the restaurant in its current configuration and not on how the restaurant previously was designed.

- 8. There was also no effort on the City Planner's part to independently verify or confirm the pre-existing activity, even though a check of his own department records would have supported it. On April 25, 2003 the Key West Planning Board specifically found that during the 1980's there was a pre-existing restaurant on this site that was much larger than the restaurant in its current configuration. See Exhibit G.
- 9. According to servers who worked at the restaurant, the configuration was entirely different with a small counter that ran the length of the left side of the restaurant, the current back wall by the restrooms was nonexistent-allowing extra seating and the area where the current bar and coffee station is located was open flooring for was table seating. On May 23, 2019, Counsel met with Elvira Quesada, a waitress at the Fourth of July for 16 years who stated that when she worked there the restaurant had

eight 4-top tables and 12 counter seats (The counter originally had more seats, but a corner section was removed to install, a cash register), giving

the restaurant a total of between 44 and 48 seats.

10. In addition to the foregoing, Petitioner is attaching the affidavit of

Alberta Brogli who worked as a server at the Fourth of July in 1974 and

recalls at least 36 seats (six 4-tops and 12 counter seats). She also

acknowledges that the size and design of the restaurant was different than

the current layout, with a much larger floor space. See Exhibit H.

11. With a larger configuration and without the existing bar, the floor

space would have been large enough to support the full seating listed on

the County license.

WHEREFORE Fernandy's Café, LLC requests the City to overrule the

decision of the City Planner, determine that the business had a preexisting

restaurant activity of between 36 and 74 seats and adjust the license

accordingly.

Back Ground:

This property has 390 sq. ft. of existing consumption area and a corresponding 26 seats. This property is the subject of a Notice of Violation No. CC2018-01867 for too many seats. During the resolution of that case, it was discovered that impact fees had only been paid for 10 seats (in 2003). According to Chapter 54, Article III, impact fees are applicable to any non-preexisting activity.

This property historically contained the Fourth of July restaurant; a well-established restaurant among the Conch and Cuban community since the 1950's. Evidence of the restaurant includes:

- Monroe County Property Appraiser's records showing pictures of the restaurant.¹
- 1984-85 Polk Phone Directory showing the phone numbers for the restaurant at this location.²
- Monroe County Tax Collector's records verifying that the Fourth of July restaurant was licensed for 74 seats³.
- Affidavits from restaurant customers estimating the seating at more than 25 seats.⁴

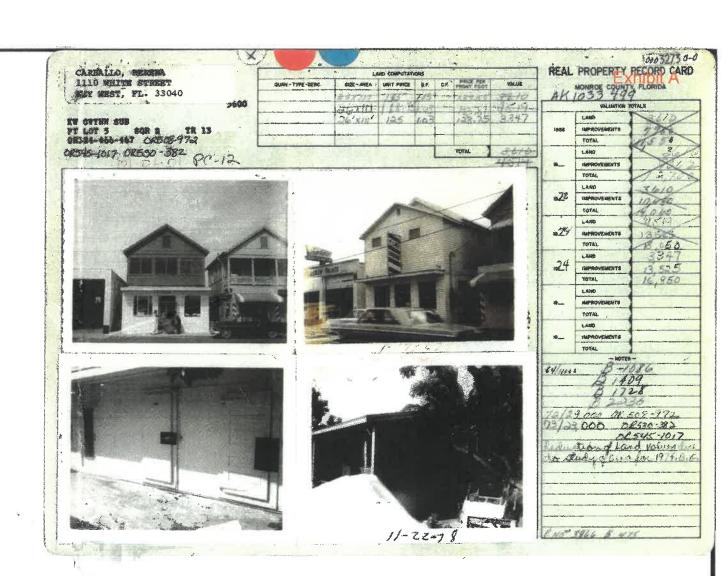

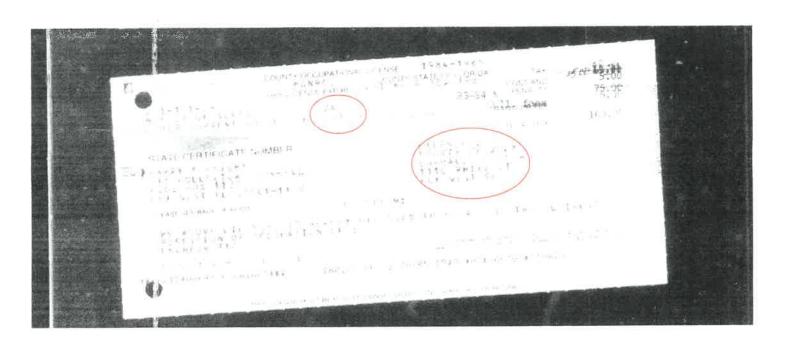
