A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF BARRACUDA BUILDERS OF KEY WEST, INC. IN RESPONSE TO ITB #19-018 FOR SMATHERS BEACH BATHROOM WEST CONSTRUCTION IN AN AMOUNT NOT TO EXCEED \$519,800.00, INCLUDING BID ADDENDUM NO. 1; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS IN SUBSTANTIAL CONFORMANCE WITH THE BID DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; AUTHORIZING ANY NECESSARY BUDGET AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 18-367, the City awarded design and prepare construction plans for a new bathroom on Smathers Beach West to Artibus Design, Inc.; and

WHEREAS, in October 2018, the City executed a Grant Award Agreement (Contract ID# 2159) with Monroe County for a Tourist Development Council (TDC) Grant Award for 100% reimbursement funding for the Smathers Beach West Restrooms Project, in an amount not to exceed \$586,000.00; and

WHEREAS, four bids were received in response to ITB #19-018 on June 5, 2019, with the bid of Barracuda Builders of Key West, Inc. being the lowest responsive bidder, including Addendum No. 1; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of Barracuda Builders of Key West, Inc., for *Smathers Beach Bathroom West* construction, in response to ITB #19-018, is hereby approved in an amount not to exceed \$519,800.00.

Section 2: That the City Manager is hereby authorized to execute necessary documents, upon advice and consent of the City Attorney.

Section 3: That this project is funded in budget account 101-7201-572-6200 (Infrastructure Surtax/Parks and Recreation/Project #IS72011901), and any necessary budget adjustments are authorized. Should the total cost of the project be less than the \$586,000.00 awarded in TDC Capital Funding, the TDC will reimburse 100% of eligible costs up to the actual amount spent.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
