Dear Madam Mayor & Esteemed Commissioners:

As I am out of the Country while the Commission Meeting of August 6, 2019 is underway, I respectfully submit this to each of you, and ask that it be read into the Public Record. The following is my perspective of the "Mall on Duval", and I will be brief.

- 1) This Initiative proposes to change the functioning of one of the most iconic, photographed, and famous streets in the United States.
- 2) This Initiative has not been brought to the Citizens of Key West through a Referendum, even though the cost of such a Referendum is a fraction of what has already been spent.
- 3) I have reviewed the Resume' of Carl Fischer, the individual hired to spearhead this Initiative. Mr. Fischer has no experience or education in an initiative of this magnitude.
