ON BEHALF OF 328 SIMONTON STREET LLC, BY AFFIRMING/REVERSING THE DETERMINATION OF THE PLANNING BOARD RENDERED IN RESOLUTION 2019-37, REGARDING TRANSFER OF ONE TRANSIENT UNIT AND LICENSE FROM 1213 GEORGIA STREET TO 328 SIMONTON STREET; PROVIDING FOR AN EFFECTIVE DATE

Section 1: That the Appeal is hereby **granted/denied** and the decision of the Planning Board is **affirmed/reversed**.
