During the final inspection of the exterior gear to get the power connected to the gym, the inspector requested that an accessible mean of disconnect be installed before the power can be energized. Therefore, listed below are three options on getting this accomplished.

Option #1

1) Description: ATS Modification: ASCO Power Services to provide and install a factory engineered kit to add Acessory 119BG (120 vac shunt trip, no 240V available) onto Catalog# J3NUSA3400CGXV, Serial# 1796099 RE, BOM# 1286963. PFEC to install lockable push button panel and pipe. Modify existing panel to interconnect these devices.

Lead time 5 to 6 weeks.
