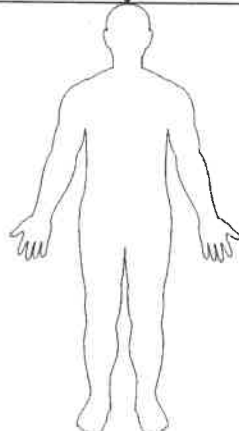

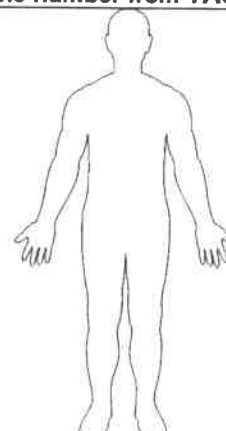

On August 9, 2019 I, Ofc. Waite, was dispatched to the Key Lime Pie Bakery located at 412 Greene Street in reference to an intoxicated subject refusing to leave the property. On arrival, an excited employee of the Key Lime Bakery, Miyoko O'Connor, ran up to my car advising the subject had just urinated against the building. O'Connor showed me the puddle of urine near the business' entrance and then told me that the suspect, later identified at Mathew Wallace, had reentered the business.

Officer Purcell and I approached Wallace who was sitting on a stool and laying his head down on a bar in the rear of the establishment. I introduced myself and advised Wallace that if he did not leave the property, he would be arrested for trespassing. Wallace asked if he had to be arrested and I told him no as long as he left the property. I asked Wallace for his name, so I could issue him a trespass warning on behalf of the business. Wallace told me that his name was "none of my business" and began to walk away. As Wallace was not yet free to leave, Ofc. Purcell and I attempted to place Wallace in handcuffs. I grabbed Wallace's left wrist and Ofc. Purcell grabbed his right wrist. Before Ofc. Purcell and I could handcuff Wallace, he pulled his right wrist away in an attempt to avoid detention. Ofc. Purcell performed a takedown on Wallace and he was handcuffed (double locked) on the floor. Wallace sustained a contusion under his left eye during the take down. Sgt. Siracuse responded shortly after to take photograph's of Wallace and his injury reference the RRI. Ofc. Purcell walked Wallace out to my patrol car as I gathered more information from O'Connor.

O'Connor told me that she first asked Wallace to leave the property as he was sleeping on a bench located near the entrance. O'Connor advised that Wallace refused and told her that she needed to be spanked. Shortly after, Wallace stood up and began urinating on the exterior of the business. Once done, Wallace entered the business and sat at the bar. Due to Wallace's volatile demeanor, O'Connor called 911 for Police assistance.

While transporting Wallace to the Monroe County Detention Center he complained of having trouble breathing. I parked my patrol vehicle and requested Rescue. Rescue 2 arrived, evaluated Wallace, and advised that there was no medical need. While back enroute to the jail, Wallace complained that he was going to vomit, that he could not breathe, and demanded that I let him out of the vehicle or face his attorney's.

Based on the facts and evidence, Wallace did knowingly and intentionally enter and remain inside of the Key Lime Pie Bakery after being asked to leave by O'Connor, an employee of the business, contrary to F.S. 810.09 - Trespass on property other than structure or conveyance.

Based on the facts and evidence, Wallace did knowingly and intentionally urinate on the exterior of the Key Lime Pie Bakery, within view of O'Connor, corrupting public morals, and outraging her sense of public decency contrary to 877.03 - Breach of the peace; disorderly conduct.

Wallace did knowingly and intentionally resist, obstruct, and oppose Ofc. Purcell while being handcuffed contrary to F.S. 843.02 - Resisting officer without violence to his or her person.

My BWC and Coban were activated throughout this call and will be uploaded into evidence.

On 8/9/2019 at approximately 2130 hours, Officer Waite and I, responded to 412 Greene St in reference to a drunk male refusing to leave the property.

Upon arrival we met with an employee who directed us to a drunk white male (later identified as Mathew Wallace) sitting in a chair in the rear of the store. Officer Waite and I approached Wallace and asked him to identify himself. Wallace refused to give us his ID or provide us with his name. Wallace stood up aggressively towards Officer Waite. I grabbed Wallace's right arm and attempted to place him in handcuffs. Wallace struggled to spin around and keep his hands apart. I locked out Wallace's right wrist and elbow performing a straight arm takedown. I placed Wallace in handcuffs.

Officer Waite transported Wallace to the Monroe County Detention Center.
