A motion was made by Commissioner Lopez, seconded by Commissioner Kaufman, that the Ordinance be Adopted with the adopted ad valorem tax general municipal millage rate for FY 2019-2020 is set at 2.1535 mills (2.1535 per thousand dollars of assessed property value). The 2019-2020 final adopted millage rate is equal to 3.50 percent more than the rolled back rate of 2.0807 mills (\$2.0807 per thousand dollars of assessed property value).
