A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA RATIFYING EMERGENCY CHANGE ORDER #1 PURSUANT TO SECTION 2-845 OF THE CODE OF ORDINANCES TO CHARLEY TOPPINO & INC. IN AN AMOUNT NOT TO EXCEED \$19,759.40 FOR ADDITIONAL SERVICES UNDER THE PAVEMENT MARKINGS, STRIPING ANDROADWAY SIGNAGE PROJECT APPROVED IN RESOLUTION 17-NECESSARY AUTHORIZING TRANSFERS/AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-169, the City Commission approved a contract titled "PAVEMENT MARKINGS, STRIPING & ROADWAY SIGNAGE ITB 17-014" with Charley Toppino & Sons, Inc.; and

WHEREAS, over the term of the contract, staff and the contractor identified areas which required additional necessary striping or curb painting, and it was costeffective to perform such additional work in areas already undergoing striping and marking tasks, to avoid the cost of mobilization to perform tasks at a later date; and

WHEREAS, the requested change order represents more than 5% of the total contract value of the project, and Section 2-845 of the Code of Ordinances requires City

Commission approval of any change order in excess of five percent of any public service building or capital improvement project; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-845 of the City's Code of Ordinances, to authorize and procure the necessary change order to provide additional road and curb markings to ensure public safety; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Change Order #1 in the amount of \$19,759.40 to Charley Toppino & Sons, Inc. for additional services under the Road Striping Project approved in Resolution 17-169 is hereby ratified, as an emergency procurement pursuant to section 2-845 of the Code of Ordinances.

Section 2: That a transfer of funds in the amount of \$19,759.40 from Paving Fund II41021802 to Striping Project II41021704 is hereby authorized for the additional work performed in the striping project.
