On October 3, 2019, I was made aware that an application is supposed to be submitted to transplant 2 clumps of Christmas Palms at the Key West Seaport restroom construction area to another location in the area. The representative for the contractor stated a concern that the palms had been damaged by the construction and felt it would be best to remove them. An application for removal of the two palm clumps was received on October 7, 2019.

On October 10, a site inspection was done which documented the condition of the palms. Several trunks in each clump have been damaged by construction activities.












The building permit directly associated with this work states a condition that "No impacts to trees during construction (staging and storage)." Further discussions with Karen Olson, Deputy Director of Port & Marine Services, indicated that she would like to have the damaged palms removed and the contractor be required to plant 4 new thatch palms with three across the front and one along the side.



Under normal permitting procedures, if the palms had not been damaged and a request was made to remove them, the replacement requirement would have been 2 native palms, 4 ft tall.

This is Sea Tech, Inc's first violation. It is recommended that they be required to plant 4 Thatch palms, 6-8 ft tall (overall height), as indicated in the drawing above submitted by Karen Olson.
