On 10/18/19, at approximately 0426hrs, I was dispatched to a report of criminal mischief at 1075 Duval Street (Circle K).

This incident involves Arnold Bruce Kravitz and how he ransacked the inside of Circle K. Connie Sue Dowds was the clerk working at Circle K during this incident. Jermaine D. Lee was a witness to the incident. Key West Police Department Communications (COMM 1) aired a description of Arnold and described him as a tall black male, wearing a black shirt and red shorts.

As I was driving toward Circle K, I turned south onto Duval Street from Truman Avenue. I saw a black male matching the description that COMM 1 previously aired. When I stopped my marked patrol car, Arnold began to run toward me and the driver side door of my patrol car. I opened my patrol car and told Arnold to stop. I deployed my Taser device toward Arnold. The effects of the device appeared minimal and Arnold appeared slightly stunned as he appeared to fall over. Arnold then attempted to shut the driver side door of my patrol car on me, which made contact with the lower portion of my body. I got out of my patrol car and Arnold ran toward the front of my patrol car. Arnold then ran toward me. I quickly ran the opposite direction around the rear of my patrol to create space between Arnold and myself. When I got around the front of my patrol car, Arnold ran back around toward the front of my patrol car. Arnold was getting closer to me and swinging his arms, in an attempt to strike me. When I attempted to subdue Arnold, he wrapped his right arm around my neck. I then wrapped my left arm around Arnolds neck in an attempt to bring him to the ground. I was able to successfully bring Arnold to the ground and handcuff him. Backup officers arrived on scene to assist me and the investigation.

I aired over COMM 1 that Arnold had been Tased, was in custody and that rescue was required to evaluate Arnold.

Sgt. Kouri took several photographs of my body and informed me that I had scratches on my neck and that my face was red.

While waiting for rescue, Arnold tried to kick me. I requested a hobble tie to secure Arnolds legs. Officer Arguello rode with rescue personnel to the emergency room.

Ofc. Arguello provided me a witness statement from Jermaine D. Lee. Jermaine stated that Arnold was "destroying" the store. Jermaine stated that Arnold was behind the cashier counter "destroying the store". Jermaine stated he instructed the cashier to lock the door, but she refused to do so. Jermaine stated Arnold left the store. Jermaine stated Arnold walked down the street (Duval Street) and tried to "attack" the police officer (Ofc. B. DeHanas). Jermaine stated after Arnold was Tased, he (Arnold) removed the taser and "ran around". Jermaine stated the officer (Ofc. B. DeHanas) then "tackled" Arnold and waited for backup to arrive.

I was unable to speak with Connie, as I needed to assist Ofc. Arguello and rescue personnel with transporting Arnold to the emergency room. Ofc. Cuneo assisted me with collecting a statement from Connie as well as photographs of the damage. Ofc. Cuneo provided me 23 photographs of the damage caused by Arnold. Ofc. Cuneo also told me Connie told him that after the delivery truck left, she heard banging outside of the store. Connie stated when she went to look, Arnold came into the store and started destroying the store. Connie stated she left and called 9-1-1.

Ofc. Cuneo told me there was damaged goods flung around the entire store as well as the computer that houses the camera system. Ofc. Cuneo told me the camera system was broken. Ofc. Cuneo told me the manager will be in later

F.S.S. 843.01, Resisting with Violence. On 10/18/19, at approximately 0426hrs, I (Ofc. B. DeHanas) find probable cause to believe that Arnold Bruce Kravitz committed the offence of resisting with violence. This offense is contrary to the Florida State Statutes. Arnold knowingly and willfully resisted me (Ofc. B. DeHanas) by doing violence to me. When attempting to detain Arnold, while waiting for rescue services, Arnold attempted to kick me. At the time, I was engaged in the lawful executions of my duties. At the time, I was a full-time sworn police officer, employed by the City of Key West and was authorized to carry out legal duties. At the time, Arnold knew I was full-time sworn police officer. I was wearing my department issued Class B uniform.

F.S.S. 784.07-2A, Assault on Law Enforcement Officer. On 10/18/19, at approximately 0426hrs, I (Ofc. B. DeHanas) find probable cause to believe that Arnold Bruce Kravitz committed the offense of assault on law enforcement officer. This offense is contrary to the Florida State Statutes. Arnold intentionally and unlawfully threatened, either by word or act, to do violence to me (Ofc. B. DeHanas). At the time, Arnold appeared to have the ability to carry out the threat of kicking me, as he legs were not fully secured. The act of kicking created in the mind of myself a well-founded fear that the violence was about to take place. I was at the time a full-time sworn police officer, employed by the City of Key West. Arnold knew I was a full-time sworn police officer. I was wearing my department issued Class B uniform. At the time of the assault, I was engaged in the lawful performance of my duties.

F.S.S. 806.13.1B3, Criminal Mischief over \$1000. On 10/18/19, at approximately 0426hrs, I (Ofc. B. DeHanas) find probable cause to believe that Arnold Bruce Kravitz committed the offense of criminal mischief. This offense is contrary to the Florida State Statutes. Arnold damaged real property. The real property was the camera system that Circle K. Operates. The property injured or damaged belonged to Circle K. The injury or damage was done willfully and maliciously. The damage to the property was greater than \$1000.

My AXON BWC and in-car COBAN cameras were activated during this incident.

Upon arrival, I noticed that Ofc. Dehannas had the suspect (later identified as Arnold Kravitz, DOB 11/10/96) handcuffed and placed on the ground. Kravitz was still resisting, attempting to stand up. Kravitz attempted to kick Ofc. Dehannas but missed. I assisted in placing a hobble around Kravitz's legs.

I interviewed one of the witnesses (later identified as Jermaine Lee, DOB 8/22/83). Lee told me that he witnessed Kravitz, "trashing" the store and the clerk walking outside. Lee stated that he told the clerk to lock Kravitz inside the store, but she would not. Lee stated that when Ofc. Dehannas arrived on scene, Kravitz "attacked" him. Lee stated that Ofc. Dehannas tackled Kravitz to the ground and placed handcuffs.

I rode with Key West Fire Rescue to Lower Keys Medical Center. I have no further involvement on this case. This incident was recorded on my BWC.
