A RESOLUTION OF THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA,
APPROVING THE ATTACHED "LITTER
CONTROL AND PREVENTION GRANT
AGREEMENT BETWEEN THE STATE OF
FLORIDA DEPARTMENT OF TRANSPORTATION
AND THE CITY OF KEY WEST, FLORIDA"
FOR CONTRACT G1G36, FINANCIAL
PROJECT NUMBER 409750-3-74-01, IN
THE AMOUNT OF \$16,000.00 (CITY MATCH)
FOR THE 'KEEP KEY WEST BEAUTIFUL
PROGRAM' (KKWB); AUTHORIZING
NECESSARY BUDGET AMENDMENTS;
AUTHORIZING THE CITY MANAGER TO
EXECUTE NECESSARY DOCUMENTS;
PROVIDING AN EFFECTIVE DATE;

WHEREAS, funding through the FDOT Keep America Beautiful
Local Affiliates Program has become available to the City of
Key West for litter prevention and control programs; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF
THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Litter Control and
Prevention Grant Agreement Between the State of Florida
Department of Transportation and the City of Key West,

Florida" (Financial Project Number 409750-3-74-01, Contract #G1G36) is hereby approved and accepted for funding in an amount not to exceed \$16,000.00.

Section 2: That grant funding will be provided on a reimbursement basis, and budget amendments are hereby authorized to accept the grant revenue of \$16,000.00 in account #403-0000-334.90-00 (Solid Waste Fund/Revenue/Other State Grants) and for expenses to be budgeted in account #403-3406-534.48-00 (Solid Waste Fund/Recycling Operations/Promotional Expenses). Required matching funds will include funds already budgeted for the Keep Key West Beautiful (KKWB) program (program materials, supplies and advertising) in the FY 19-20 budget, along with in-kind staff time and volunteer hours for KKWB.

Section 3: That the City Manager is authorized to effectuate any necessary budget transfers in accordance with the grant agreement, and to execute any necessary documents.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
