A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED REVISED FEE SCHEDULE FOR WORK PERFORMED BY THE CITY OF KEY WEST AT THE KEY WEST CEMETERY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 22-60 of the Code of Ordinances specifies "... to ensure the quality of the work and to minimize interference with the peacefulness of the grounds, unless otherwise approved by management under such reasonable conditions as it shall impose, all work incidental or connected with the digging of graves, breaking of foundations, breaking of copings, or opening of city-built vaults and mausoleums, shall be done, and performed by management and management shall be entitled to receive and to collect from the plot owner, in advance, the prices or charges therefor in accordance with the schedule of charges posted in the sexton's office that are in effect at the time any such work is ordered;" and

WHEREAS, the schedule of cemetery prices/fees has not been amended in several years, and City staff recommends adjustments, due to the increasing cost of providing services; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached revised fee schedule for the Key West Cemetery is hereby approved.

Section 2: That the fee schedule for the Key West Cemetery shall increase by 5% annually, to become effective on October 1, 2020, and each year thereafter, until or unless amended by Resolution of the City Commission.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
