This complaint is against officer Rodriguez for failing to intervene when he witnessed my families Constitutional rights and Florida Statute being violated on his behalf, sending my family into a terrified panic.

On June 20th Officer Rodriguez was at my front gate asking me to come outside to "just talk" ...this went on for some time until he said "I just want you to sign something" ..I told him I would sign the paper if he passed it through the gate , he refused, then officer Vasquez made a incredibly threatening statement while gripping my gate with both hands and shaking it while a firearm was visible on his side..he said "We don't want to break down your gate , we don't want to break down your front door and come into your house." ..I was visibly shaken by this threat of home invasion and harm to my family, my wife ran into the other room crying thinking we were moments away from have rouge police raiding our home, the threat was real , we were both terrified. And it was very very clear that when Vasquez states "WE don't want to break down your door" that he was including Rodriguez since it was his paperwork that he was their to get signed, the threat felt like it came from both of them, and nobody blinked an eye when I pointed out I was being threatened. My Wife and I felt threatened by both Rodriguez and Vasquez. This complaint focuses on the action and postions by Officer Rodgiquez. Vasquez is being addressed separately.

Officer Rod was the point man on the scene, it was his paperwork they were there to get signed. Officer Rod did nothing when the threat of home invasion was made, he saw that I was terrified and he still failed to intervene when he saw illegal threats being hurled towards my home and family by Vasquez.

Rod has a legal and Constitutional obligation to intervene when he is witness to a fellow officer violating the constitutional rights of a citizen. Section 1983, Title 42 of the United States Code makes it unlawful for anyone acting under the authority of State law to deprived another person of his or her rights under the constitution or Federal Law.

Officer Rod failed to intervene when he witnessed my constitutional rights being violated, he also failed to intervene when Vasquez verbally made threats towards my family and me violating Florida Statute 784.048(c)...that states .." ..Credible threat" means a verbal or nonverbal threat...which places the person who is the target of the threat in reasonable fear for his safety of the safety of his family membersand which is made with the apparent ability to carry out the threat to cause such harm, it is not necessary to prove that the person making the threat had intent to actually carry it out"

Further more, Officer Rodriguez was at my house with his threatening officers acting on a phone call I placed from outside the jurisdiction of Key West, and as the CRB already knows , jurisdiction falls where the call is placed , not by where the victim is. Officer Rodriguez failed to confirm the call came from within his jurisdiction before he filed his order with a judge... completely misleading the judge to believe it fell under their jurisdiction.

The CRB has visited this issue in the past, the City of KW and the KWPD claimed that jurisdiction fell where the call was placed, the CRB agreed with them. It seems Officer Rodriguez rejected this position by the KWPD, the City of KW, and the CRB own vote. Specifically Florida Statute 365.16 ... the KWPD, The City of KW and the CRB all agree that jurisdiction falls where the call is placed, not where the victim is.

I view this as a direct threat to the good people of Key West.

- I am accusing Officer Rodriguez of failing to intervene when my families
 Constitutional rights and Florida law was violated by Vasquez on his behalf, and while
 he was standing next to Vasquez.
- 2. Rodriguez also violated my rights and the law when he deceived the Judge by claiming he confirmed the call came from his jurisdiction.
- When Judge Fowler was confronted multiple times with the fact her paper was signed by threat of home invasion by Rodriguez and Vasquez she refused to say the police officers acted properly.

The CRB has visited the Florida Statute 365.16 and has voted in agreement with the KWPD and the City of KW that jurisdiction for 365.16 is where the call was placed. This is a different Officer, but I expect the CRB's vote to be consistent with their past position on the Florida Statute. I expect the CRB board to explain to Rodriquez that his legal position on 365.16 is not accurate, and that the CRB, the KWPD, and the City of KW thought they made it very clear that Statute requires that jurisdiction falls where the call is placed. And if the Officer isn't clear on the issue the CRB can suggest that the Officer, and anybody else that is confused go to the City of Key West website and watch the video that is open to the public where the CRB explained, and then voted that jurisdiction falls where the call is placed, not where the victim is.

And to avoid any further confusion by the CRB, it's director, and the lawyer advising them, I would suggest a retraining, as in past CRB hearings it was stated and voted upon that a CRB complaint handed to the IA was optional for the KWPD IA to review/investigate it, and that it could be shelved without review or investigation by the IA according to Florida Statute 112.533. Yet the Law is very clear on this issue, this is a "shall law" ...something attorney Citron is not familiar with... these complaints MUST be reviewed/investigated by the IA or another authority. In fact the City of Key Wests Website also states under the complaint process the "IA has 45 days to complete an investigation or inquiry and forward it" In the last hearing I attended I read the policys and procedures that dictate the complaint process to the CRB, on video, the CRB, it's director, and it's attorney all rejected their own policy in order to protect a crooked police officer.

That hearing made the front page of the KW Citizen, top story...imagine when the CRB now votes again against their own policy...and even vote in direct contradiction of their past votes...all in the pursuit of the same goal, covering up crimes by police officers. There are now two publications watching this story.

The CRB voted jurisdiction falls where the call is placed concerning 365.16, I expect them to be consistent, I also expect them to de-escalate a dangerous situation by following their own policies and procedures as posted on the City of KW 's website.

If the CRB board and attorney move to contradict their last vote or to ignore their own policy again, I will expect the director to step in and remind the board of the previous positions that they have taken in regards to Steve Legnaioli

Additional evidence for complaint # 10-004 against O'Connell.

O'Connell was at my house on June 20th around 5 pm when I asked him how the case was going against the man who called and threatened my family with murder (case#19-1825), he responded, "State attorney Weber has said they can move forward with a subpoena for the phone records with the information they have" ... There is video of this false statement, a statement made to further coverup a threat to kill my family.

- O'Connell didn't turn the case over to the proper jurisdiction (per KWPD and the City
 of KW) after he found out where the call came from.
- 2. O'Connell didn't even talk to Weber about the Subpoena, as I later called Weber later to thank him and he had no idea what I was talking about.
- 3. O'Connell is just a long list of KWPD Officers, Sargants, Captains, and Chiefs that have targeted my family in a similar manner...by covering up crimes committed against my family.
- 4. O'Connell just put my case on the shelf ..and never took any action , and never got back to me about a urgent case where my family was threatened with murder.
- 5. The CRB, KWPD, and the City of KW made it very clear that concerning Florida Statute 365.16 that jurisdiction falls where the call is placed, not where the victim is. I ask that this issue with O'Connell gets addressed so that he comes into compliance with Florida law as interpreted by the CRB and the KWPD.
