On February 5, 2020, an e-mail was sent to eight companies that routinely purchase and transport trees in the City with a request for estimates for the purchase of street/right of way trees, 50-65 gallon sized trees to be delivered to the City yard.

4-Spanish Stopper * 1 or 2 trunks accepted (need tall not fat)

2-Jamaican Caper * 1 or 2 trunks accepted (need tall not fat)

2-Paradise trees

4-Thatch Palms, 8 ft of wood

None of the estimates received include all species at the ideal size of 65 gallon for street trees. Only one estimate includes 65 gallon sized trees (Blue Native) but the height of the palm trees was not indicated in the estimate. 45 gallon sized trees are acceptable.

If a proper working irrigation system is not in place, it is recommended that one be installed. If customer cannot, or chooses not to install an irrigation system, it is important that the new plantings are watered daily for a period of at least 30 days. Watering may then be decreased to every other day. New plantings should receive a slow release starter fertilizer and mulch at the time of install. It is recommended to fertilize and mulch all plants and trees on a quarterly basis.
