A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S GENERAL UTILITIES CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$1,167,854.18 FOR THE PATRICIA AND ASHBY NEIGHBORHOOD PIPING STORMWATER PROJECT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-292, the City Commission approved a three-year General Utilities contract with Charley Toppino & Sons, Inc., in Resolution No. 18-014 the Contract was amended to incorporate certain Federal Contracting provisions, and in Resolution 18-322 the contract was renewed for two years; and

WHEREAS, the Patricia and Ashby neighborhood is one of the lowest elevation neighborhoods in Key West, and this project will improve and expand the drainage system, to connect to a pump station that will force stormwater out through a pressurized well unaffected by tides, as well as an emergency outfall system for intense storms and hurricanes; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION  
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Task Order under the City's General Utilities Contract with Charley Toppino & Sons, Inc. in a total amount not to exceed \$1,167,854.18, for the Patricia and Ashby Neighborhood Piping Stormwater Project is hereby approved.

Section 2: That this project will be funded in part with a Florida Keys Stewardship Grant in an amount up to \$480,000.00, and funds are budgeted in account Utilities/Stormwater/Collections/Construction 402-3803-538-6500, Project ST39031901. Any necessary budget adjustments are authorized.

Section 3: That the City Manager is authorized to execute any necessary documents for this Task Order, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
