A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO CODE OF ORDINANCE SECTIONS 2-797(1)(a)(b)(c) SOLE SOURCE AND 2-844(a)(b)-BRAND NAME SPECIFICATIONS, AND 2-797 (4)(b)-BEST INTERESTS OF THE CITY, THE PURCHASE OF FARO 3D CRIME SCENE MAPPING BUNDLE AND RELATED TRAINING, WARRANTY AND EQUIPMENT FROM FARO TECHNOLOGIES, INC. IN AN AMOUNT NOT TO EXCEED \$86,821.69; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 19-303, the City Commission authorized acceptance of Grant Award No. EMW-2019-PU-00312 from the Department of Homeland Security Port Security Grant Program for acquisition of an unmanned aircraft system and 3D Laser Scanner Camera; and

WHEREAS, FARO Technologies 3D mapping equipment is the only equipment brand that can comport with the FBI in the event of a catastrophic event at a Key West port, and FARO Technologies, Inc. is the only authorized vendor for FARO products in the state of Florida, and therefore department staff recommends the purchase of the Fara 3D Crime Scene Mapping Bundle, as described in the attached price quote, on a sole source, brand name preference; and

WHEREAS, the City Manager has determined that the purchase of FARO Technologies 3D mapping equipment from FARO Technologies, Inc., for use by the KWPD, as described in the attached price quotes, is in the best interests of the City pursuant to section 2-797(4)(b) of the Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a FARO 3D Crime Scene Mapping Bundle with related equipment and training from FARO Technologies, Inc., in the amount of \$83,821.69, is hereby approved, pursuant to Code of Ordinances Sections 2-797(1)(a)(b)(c) and 2-844(a)(b), sole source brand name procurement and 2-797(4)(b), best interests of the City.

Section 2: That this purchase is funded for FY 19/20, with grant revenue from account 001-0000-331-2000(General Fund/Revenue/Public Safety), and from Budget account 001-2104-521-6400 (General Fund Law Enforcement Grants/Machinery and Equipment).

Section 3: That the City Manager or designee is authorized to execute any documents necessary for the purchase, upon advice and consent of the City Attorney.
