FIRST AMENDMENT TO SUBMERGED LANDS LEASE AGREEMENT

1. The reference to "Containing approximately 15,750 square feet" in the description of the Submerged Lands Lease Agreement, pertaining to Parcel H, is deleted and replaced with "Containing approximately 19,874 square feet"

2. The document attached to the Submerged Lands Lease Agreement and referred to as "Attachment A" in the description of the Submerged Lands Lease Agreement is hereby deleted in its entirety and replaced with "Attachment A-1", which is attached hereto and incorporated by reference.

3. The reference to Lease Fees in Paragraph 2 shall be amended to state that effective June 1, 2020 the Lease fees shall be amended to reflect the the following:

Monthly Lease Fee	\$579.66
Sales Tax	\$41.74
Total Monthly Fee	\$621.39

Thereafter the Monthly Lease fees will be adjusted on September 1^{st.}, the anniversary date of the lease.

4. Except as modified herein, the Submerged Lands Lease Agreement as amended shall remain in full force and effect.
