A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA) AWARDING THE BID OF EBSARY FOUNDATION COMPANY IN RESPONSE TO ITB #20-005 IN A TOTAL AMOUNT NOT TO EXCEED \$485,500.00 FOR DOCK REPAIR AND PILING REPLACEMENT FOR THE KEY WEST HISTORIC SEAPORT (KB1505); AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS IN CONFORMANCE WITH THE BID DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, five responsive bids were opened on December 18, 2019, in response to ITB #20-005, and at its meeting of February 12, 2020, the Key West Bight Management District Board recommended award of bid to the lowest responsive bidder; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That the bid of Ebsary Foundation Company is hereby awarded in an amount not to exceed \$485,500.00, in response to ITB #20-005, the terms and conditions of which are incorporated herein.

Section 2: That funding for this project is budgeted in account 405-7503-575-6300 (Project No. KB1505).

Section 3: That the City Manager is authorized to execute any necessary documents, in conformance with the bid documents, upon the advice and consent of the City Attorney.


Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.

ACTION STATEMENT

Resolution approving low bidder, Ebsary Foundation Company, for ITB #20-005 Dock Repair & Piling Replacement – Key West Historic Seaport and authorize the City Manager to execute the contract in the amount of \$485,500.

BACKGROUND

In May of 2017 Seaport staff issued a Task Order to Tetra Tech for Key West Bight Marina Pile Assessment. The assessment, dated October 2017, indicated that there were several pilings, cross-brace/horizontal structural assemblies and through rod/anchor-bolt hardware assemblies in need of replacement throughout the Marina.

In early 2019 the most severely deteriorated dock members and pilings were replaced under ITB #18-005 approved through Resolution #18-361. This project includes the remaining pilings, cross-brace/horizontal structural assemblies and through rod/anchor-bolt hardware assemblies as outlined in the assessment. The project also includes the installation of eight steel pipe mooring pile at the Ferry Terminal Pier.

The Key West Bight Management District Board approved this item at their February 12, 2020 meeting.

PURPOSE AND JUSTIFICATION

Seaport Staff issued ITB #20-005 for Dock Repair & Piling Replacement. Bids were received on December 18, 2019 from five contractors.

Bids were reviewed, and Ebsary Foundation Company was determined to be the lowest responsive bidder.

FINANCIAL ISSUES

The Seaport budgeted for this project in Key West Bight Fund/ Marina Operations/ Infrastructure account 405-7503-575-6300 KB1505. Upon approval, a purchase order will be issued to Ebsary Foundation Company in the amount of \$485,500.

RECOMMENDATION

Key West Bight Management District Board recommends approving low bidder, Ebsary Foundation Company, for ITB #20-005 Dock Repair & Piling Replacement - Key West Historic Seaport and authorize the City Manager to execute the contract in the amount of \$485,500.


