

On April 27th, 2020 at approximately 0107 hours, I (Officer Deese) was dispatched to 3726 Cindy Avenue in reference to a verbal altercation happening in the area. While responding to the call for service, a second caller contacted the police department reporting the loud verbal dispute happening in the area.

The first reporting party, Robyn Romanoff, and her husband were standing on Cindy Avenue when I approached the area. Once contact was made, the husband stated that there was a group of younger males arguing and yelling at each other in the front yard next to their house. The husband stated his family was sleeping when they heard the altercation. He stated after about 30 minutes of listening to them argue he heard what sounded like one of the males punching and hitting a vehicle. He stated that's when he called the police.

While talking to the husband, I witnessed a white male walk out of a neighboring front yard. Once contact was made, he stated that one of his friends, later identified as Robert Charles Curry by his name and date of birth, invited another male, identified at Aldo Hamilton by his name and date of birth, over because he was "talking like he was upset" and that he wanted to figure out what was wrong with him. The male stated that Curry had invited Hamilton over to their house. About this time, I heard Ofc. Leo Hernandez state that he was out with two Hispanic males with no shirts on around the corner from my location. I informed Ofc. Hernandez over the radio that those males are possibly the other subjects to the altercation I was investigating. Ofc. Hernandez stated one of the males charged at him and that he displayed his taser.

At this time, I left my location and the male I was speaking to, to assist Ofc. Hernandez. Upon arrival to Ofc. Hernandez's location, I witnessed Aldo Hamilton belly down on the pavement with his hand tucked under his face against the pavement. I heard Ofc. Hernandez give him verbal commands to spread his hands and arms straight out on the pavement. Hamilton did not comply. I approached Hamilton on the right side of his body and Ofc. Hernandez approached from Hamilton's left side. Upon taking control of Hamilton's right arm, he tensed and tried to rip his arm out of my grip. I told Hamilton to stop resisting. He did not comply. Once Ofc. Hernandez and I successfully placed the handcuffs on Hamilton, Ofc. Hernandez went to talk to Curry who was sitting nearby. I was unable to double lock or check the handcuffs for tightness at this time due to Hamilton tensing and pulling away from me. I was located next to Hamilton while he was laying on his belly face down with his hands cuffed behind his back. Hamilton was repeatedly saying "red", "Lord", and "God". Hamiltons actions and words were consistent with someone under the influence of a hallucinogen.

After approximately 30 seconds, Hamilton rolled to his side, got his knees under him and tried to push up into my legs to take me off my feet. I was able to use my body weight to pin Hamilton to the ground where he continued to roll around and resist my commands. I told Hamilton to "stay down" which he failed to do. Ofc. Hernandez helped me get Hamilton under control by physically pinning him down against the ground using our body weight. During this altercation, my BWC was knocked off my uniform.

K-9 Officer Matthew Hansell and Officer Hudson arrived at the scene and helped physically restrain Hamilton from harming officers. Ofc. Hansell and Ofc. Hernandez both gave commands for Hamilton to stop moving and to stop fighting. During this time, Hamilton continued to tense and try to roll out from underneath me. Ofc. Hudson told Hamilton that he would get tased if he continued to fight. Hamilton stated that he "had no reason to fight" and "please don't tase me I have no reason to get tased". Ofc. Hudson informed him that if he continued to fight, the taser would be used. Hamilton refused to untense his muscles after multiple commands were given to him to do so. Ofc. Hudson drive stunned Hamilton to get him to comply with officer commands. Hamilton continued to tense and began kicking his legs and trying to roll his body. At this time, Ofc. Hansell placed a hobble on Hamilton's legs to

prevent him from kicking any of the officers on scene. While placing the hobble on, Hamilton continued to tense his muscles and tried rolling out from underneath officers. Ofc. Hudson used his taser again to get Hamilton to comply with our commands. Ofc. Hudson informed Hamilton that he would continue to get drive stunned if he did not stop fighting. At this time, Ofc. Malak, Ofc. Husdon and Ofc. Hernandez were trying to constrain his upper body while I was using my body weight to pin down his legs to prevent him from kicking.

I placed a spit hood on Hamilton to prevent him from spitting on officers on scene. Once rescue arrived, Ofc. Malak and Ofc. Hernandez picked Hamilton up and placed him on his feet. Sgt. Sims had control of the hobble placed around Hamilton's Knees. Hamilton Repeatedly went limp after being told to walk to the back of the ambulance. Ofc. Hernandez and Ofc. Malak had to physically carry Hamilton to the back of the ambulance due to him resisting commands to walk.

Hamilton had to be strapped to the stretcher due to him constantly trying to resist. Key West Fire and Rescue transported Hamilton to Lower Keys Medical Center. Ofc. Hernandez rode with Hamilton and KWFR to the hospital.

Ofc. Tellier made contact with Curry and his supplemental report states the following:

"On 04/27/20 at 0105 hours I, (Ofc. J. Tellier) responded to the 3700 block of Cindy Avenue in reference to a combative arrestee. Ofc. Deese and Ofc. Hernandez were engaged in a physical fight with a man name later identified as Aldo Jesus Hamilton.

Upon my arrival, Hamilton was restrained with handcuffs and being held down by Ofc. Deese, Ofc. Hernandez, and Ofc. Hudson. Hamilton was screaming and kicking his legs while laying on the ground. Ofc. Hudson used pain compliance (cartridge off drive stun) attempting to gain compliance from Hamilton, with little effect. Ofc. Hansell was standing by with another man, Robert Charles Curry, who was sitting on the sidewalk relaxed during this commotion.

Hamilton was still kicking and tensing, so I assisted Ofc. Hansell with applying a hobble to Hamilton's ankles.

I spoke with Curry and asked him to tell me what happened. He stated Hamilton came to his home and was screaming about god on his front lawn, making a lot of noise. He stated he tried to quiet Hamilton but he continued to scream. While screaming, Hamilton punched him in the face repeatedly. He stated he grabbed Hamilton to calm him down. Hamilton was still screaming, so Curry attempted to walk him home. While walking Hamilton home, Officers Deese and Hernandez made contact with them.

Curry's face was red but I saw no visible injuries and he decline medical treatment. Curry stated some flower pots were broken at the house, so I escorted him back to 3726 Cindy Ave. to inspect the damage. At the home I found 3 broken flower pots in the front lawn. Curry stated he didn't want to press charges against Hamilton for being punched or breaking the flower pots.

While at the address I found a clear plastic bag (laying in the grass) containing a green leafy substance which resembled Marijuana. Curry stated Hamilton must have dropped it while he was creating all the commotion on his lawn. I took the bag of Marijuana as found property for destruction. At the Key West Police station I tested the suspected Marijuana, and it field tested positive and weighed 1.4 Grams. I generated case number 20-2060 in reference to the found Marijuana. "

Once Hamilton was transported to the hospital, I went to Monroe County Detention Center to begin paperwork while Ofc. Hernandez and Ofc. Malak stayed with Hamilton at Lower Keys Medical Center.

Based on the facts and evidence, I believe there is probable cause that on April 27th, 2020, Aldo Hamilton did knowingly and intentionally disrupt the peace by affecting the peace and quiet of persons who may have witnessed them, and engaged in brawling or fighting, violating F.S.S 877.03 BREACH OF PEACE; DISORDERLY CONDUCT.

Based on the facts and evidence, I believe there is probably cause that on April 27th, 2020, Aldo Hamilton did knowingly and intentionally resist, obstruct or oppose a law enforcement officer while the officer was in the execution of legal process violating F.S.S 843.02 RESISTING OFFICER WITHOUT VIOLANCE.

My BWC was activated during the incident and uploaded to Axon Evidence.com.

On 04/27/2020 at approximately 0113, while on routine patrol in the City of Key West, I responded to the area of 19th St and Cindy Ave in reference to a subject who was actively resisting Officer L. Hernandez. On arrival I observed Officer L. Hernandez and Deese on the ground with a male attempting to gain control.

The subject, who was later identified as Aldo Hamilton, was attempting to get off the ground. I drew my agency issued Taser, removed the cartridge and placed in on the back of his upper right arm. I told Hamilton to stop fighting or I would apply a drive stun with the Taser. Hamilton then tensed his muscle and began to attempt to stand. I applied one full cycle. Hamilton then stopped. Hamilton again tensed his muscle and began to pull away and attempt to stand. I again applied one full cycle to the same area. Hamilton again became compliant. These same actions were repeated two more times in the same area to prevent any further injury to Hamilton or any Officer.

During this time, Officer Hansell placed a hobble restraint around Hamilton ankles as to stop him from kicking. Hamilton tried to used his hands several time to grab my left leg, tensing his muscle and attempting to stand. I applied one drive stun to his right lower hip area to gain compliance and prevent injury. Hamilton turned his head toward me, tensed his muscle and tried to push away. I applied one final drive stun to his right shoulder area. Hamilton again became compliant.

It should be noted, Hamilton was layed on a loose gravel surface with his head just over the pavement. During this event, Hamilton was spitting and did later have a spit mask placed over his face.

Sergeant Siracuse responded to the scene and photographed the signature marks in the three areas.

Hamilton was transported to Lower Keys Medical Center with Officer L. Hernandez.

All of the above was captured on my bodyworn camera, 3940.

Nothing further at this time.

Hamilton was transported to Lower Keys Medical Center for examination.

My BWC recorded my portion of this investigation.

On Sunday April 27th, 2020, at about 0105 hours, I, Ofc. (L. Hernandez) was dispatched to 3627 Cindy Avenue in reference to a verbal dispute incident.

Upon arrival in the area, while I was driving West on 20th Street, I found two shirtless males in the middle of the road. The two males were later identified as Aldo Jesus Hamilton (DOB 12/27/1991 FL DL # H54301091467) and Robert Charles Curry (DOB 11/20/1998 FL DL # C600763984200). I stopped as I noticed that Hamilton was acting odd by swinging his arms around, walking side to side and yelling "the devil got me, the devil got me", all while on the middle of the road. I started to give loud and clear verbal commands asking them to get off the road. Curry complied and tried telling Hamilton to listen to my commands, but he kept screaming, babbling and ranting nonsense, saying "Jesus take me, oh man the devil got control of me".

I was able to lead Hamilton to the gravel area near the curb on 20th Street. Hamilton kept screaming and ranting and then he started to physically and actively come at me, while swinging his arms side to side and jumping up and down. As I was giving Hamilton loud and clear commands to back off and to get on the ground, I displayed my taser towards him while ordering Curry to get back and remain within sight.

After I gave several loud and clear commands, Hamilton complied by getting on the ground. I asked Hamilton to extend his arms out and place his palms up. Ofc. J. Deese arrived on scene and started to try to detain Hamilton while I was pointing my taser at him and keeping an eye on Curry. I had to go in and grabbed Hamilton's left arm while Ofc. Deese had control of his right arm so he could be handcuffed, then I holstered my taser. During and after being handcuffed Hamilton kept trying to get up by pushing his head and back up and swang his shoulders side to side to defeat being detained.

Ofc. A. Hudson, Ofc. Malak and Officer Hansell then arrived on scene and gave several loud and clear commands to Hamilton asking him to stop trying to defeat our attempts to keep him detained. Ofc. Hudson had to drive stun Hamilton while I, Ofc. Hansell, Sgt. Sims and Malak tried to hold Hamilton down and a Hobble had to be used to restrain his legs.

Key West Fire Rescue 3 was dispatched and arrived on scene. Hamilton was transported to the Lower Keys Medical Center Emergency room where he was evaluated and eventually released. Hamilton was still ranting nonsense at the Hospital saying, "Oh shit, oh shit, Jesus take me, oh shit I fucked up, am I going to die, the devil got control of me".

Hamilton was released and transported to the Monroe County Detention Center by Ofc. Malak and I. Hamilton was turned over to the Monroe County Detention Deputies without further incidents.
