RESPONSE TO ITB #21-004 A THREE YEAR CONTRACT IN THE INITIAL (FY 20/21) AMOUNT OF \$29,502.00 PER YEAR FOR MOORING FIELD (THREE INSPECTIONS INSPECTIONS \$9,834.00 PER YEAR), WITH ANNUAL CPI ADJUSTMENTS, AND AN OPTION FOR ONE 2-YEAR EXTENSION); AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN ITB #21-004, UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West operates a mooring field where the City has identified a need for inspections of up to 149 permitted mooring systems every four months, along with replacement of deficient mooring systems as necessary; and

WHEREAS, Seamar Divers, LLC submitted the lowest responsive bid in response to ITB #21-004;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Seamar Divers, LLC in response to ITB #21-004 for mooring field inspections, is hereby awarded at a price of \$29,502.00 per year (\$9,834.00 per inspection), for FY 20/21, for a contract term of three years

with an allowable CPI increase for each additional budget year, and an option for one two year extension.

Section 2: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained in ITB #21-004, upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
