A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A CHANGE ORDER TO CHARLEY TOPPINO & SONS, INC. FOR ADDITIONAL TASKS FOR THE BERTHA STREET STORMWATER SYSTEM RELATED то THE DENNIS STREET PUMP STATION PROJECT, 100% ALLOCABLE TO MONROE COUNTY IN AN AMOUNT NOT TO EXCEED \$65,748.00; AUTHORIZING NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING CITY THE MANAGER OR DESIGNEE TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 20-041 Charley Toppino & Sons, Inc. was awarded a contract for Dennis Street Stormwater Pump Station Project (ITB 19-015); and

WHEREAS, in Resolution 20-050, the City Commission approved an "Interlocal Agreement for Engineering Design, Permitting and Construction Services for Dennis Street Pump Station (Key West) Project" between Monroe County and the City of Key West for cost sharing of certain components of the project; and WHEREAS, the additional work contemplated in this change order is 100% allocable to Monroe County, and will be reflected in an amendment to Interlocal Agreement to be presented on a future Commission agenda; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a Change Order to Charley Toppino & Sons, Inc. for additional tasks related to connection and piping for the County's Bertha Street roadway project in an amount not to exceed \$65,748.00 is hereby approved.

Section 2: That funds for this project are allocated in account 402-3802-538-6500 (Project ST38021601), and are expected to be 100% reimbursed by Monroe County through an ILA Amendment. Any necessary budget adjustments are hereby authorized.

<u>Section 3</u>: That the City Manager or designee is authorized to execute any necessary documents related to this Change Order, upon consent of the City Attorney. Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
