WHEREAS, in January 2021 the TruPortal access control system, which had provided secure access to the Dinghy Dock, Liveaboard and Transient bathhouse facilities, stopped functioning; and

WHEREAS, TruPortal Access Solutions stopped providing service and equipment support, and the Adobe interface the system relied upon was discontinued in January 2021, so the access system requires full replacement; and

WHEREAS, without a functioning access system, the restroom facilities must be left unlocked, which poses a security risk for tenants and the City; and

WHEREAS, City staff had been researching access control providers, with the intention of replacing the system in FY 22, but in the interests of tenant safety, it became necessary to replace the system immediately; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, and executed an Emergency Procurement on January 28, 2021, to authorize and procure new access control systems from MinuteMan Security Technologies to remedy the clear and present threat to public property and the welfare of tenants at Garrison Bight; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an emergency task order for MinuteMan Security Technologies is hereby ratified pursuant to section 2-797(2), in an amount not to exceed \$58,283.54 for installation of access control systems at the dinghy dock and the liveaboard/transient bath houses at Garrison Bight.

Section 2: That a transfer of funds in the amount of \$58,283.54 from Garrison Bight Reserves account 413-7552-575-9803 into the Repairs and Maintenance Account Nos. 413-7551-575-4600 (liveaboard & transient bathhouses - \$31,558.70) and 413-7554-575-4600 (dinghy dock bathhouse - \$26,724.84) for this project is hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents to effectuate the purchase and installation of the access control systems.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.

ACTION STATEMENT:

Ratification of Emergency Declaration and budget transfer for the procurement of the City Marina's Access Control System to MinuteMen Security Technologies in the amount of \$58,283.54 pursuant to Subpart A, Chapter 2, Article VII, Division 3, Subdivision 2, Sec. 2-797 of the City of Key West Code of Ordinances executed by the Assistant City Manager on January 28, 2021.

BACKGROUND:

City Marina at Garrison Bight has three restroom/ shower facilities, the dinghy dock bathhouse, the liveaboard bathhouse and the transient showers/ restrooms located in the new Dockmaster building. These facilities were controlled by an access control system manufactured by TruPortal Access Solutions. This system allowed us to control and monitor use of the facilities by distributing card keys to the users. As of late 2019/early 2020 TruPortal is no longer providing services or equipment.

The access control systems at the dinghy dock and liveaboard bathhouses started having issues in early spring of 2020 but we were able to scavenge parts from other locations to keep them up and running. We have been researching new systems to budget for the upcoming fiscal year.

PURPOSE & JUSTIFICATION:

In early January 2021 the Adobe interface for the Truportal system shut down rendering the City Marina's access control system useless. Not having access control to our facilities requires the City to leave the restrooms unlocked which is not in the best interest of our tenants or the City. We have worked diligently to come up with a system that will fit our needs, is upgradeable and can integrate with the Key West Historic Seaport and City Hall. We consider this an emergency and are asking that we move this forward as expeditiously as possible per Section 2-797(2): Emergency procurement as there exists a "clear and present threat to public health, property, welfare, safety".

Key to the Caribbean - Average yearly temperature 77° F.

With written approval first from Mark Finigan, Finance Director, followed by Patti McLauchlin, Assistant City Manager, verbal approval was given to MinuteMen Security Technologies to proceed with the equipment purchase. Staff then followed through with a formal Declaration of Emergency approval for issuance of purchase order. We anticipate the equipment to be shipped the week of February 9th followed by installation.

FINANCIAL IMPACT:

This was an unbudgeted expense for the dinghy dock bathhouse \$26,724.84 and the liveaboard/transient bathhouses \$31,558.70. Funds in the total amount of \$58,283.54 were transferred from Reserves.

RECOMMENDATION:

Staff recommends ratification from the Commission to MinuteMen Security Technologies in the amount of \$58,283.54 pursuant to Sec. 2-797, Emergency Procurement for the City Marina's Access Control System and authorizing the budget transfer.

As discussed our access control systems at both marinas are completely down both because of software that cannot be fixed and hardware that is either old and can't be upgraded (truportal is out of business) or the need to add automation to manual push bars in order for access control to be installed. Basically we are having to completely start over at both marinas which was not expected this budget year. Not having access control to our facilities (bathroom/showers/laundry) allows them to become a free for all which is never good. Karen and I have worked diligently to come up with a system that we believe will fit our needs, is upgradeable, and the manufactures that supply the parts will be around for a while. We have a handle on the costs and system that needs to be installed at KWB. We are working on City Marina at Garrison Bight which will be significantly higher than KWB because of the number of doors and facilities.
