CANCELLATION OF LEASE AND ASSIGNMENT OF SUBLEASE

(10) 3496

This Cancellation of Lease and Assignment of Sublease entered into this 500 day of 1950, by and between BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND, hereinafter referred to as "Board", and DEPARTMENT OF NATURAL RESOURCES, DIVISION OF RECREATION AND PARKS, hereinafter referred to as "DRP".

WITNESSETH:

WHEREAS, on June 11, 1987, Board and DRP entered into Lease No. 3496 under which certain lands were leased by Board to DRP for the sole purpose of being subleased to local governments for environmental protection and compatible outdoor recreation; and

WHEREAS, on June 7, 1989, DRP subleased the lands described in Lease No. 3496 to City of Key West through Sublease No. 3496-01; and

WHEREAS, Board and DRP agree that the role of DRP as an intermediate party in the management of lands described in Lease No. 3496 and Sublease No. 3496-01 is no longer necessary or desirable.

NOW THEREFORE, in consideration of the hereinabove and hereinafter mutual covenants and undertakings, the receipt and sufficiency of which are conclusively acknowledged, the parties agree as follows:

- 1. DRP hereby releases, assigns and quitclaims all of its right, title and interest in Lease No. 3496 and the lands leased thereunder to Board and agrees to the cancellation of the same of record.
- 2. DRP hereby conveys, transfers and assigns all of its right, title and interest in Sublease No. 3496-01 to Board, and Board hereby accepts and assumes all the duties and responsibilities of DRP thereunder.
