A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER FOR THE "FINAL MILE" PROJECT BETWEEN THE CITY AND TETRA TECH, INC. IN THE AMOUNT OF \$40,896.00 FOR THE PREPARATION OF CERTAIN PLANS AND SPECIFICATIONS FOR THE PROJECT; AUTHORIZING FUNDING FROM THE TRANSPORTATION ALTERNATIVE FUND RESERVES ACCOUNT 111-4903-549-9803 AND ANY NECESSARY BUDGET AMENDMENTS AND ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 20-039, the City Commission signed a contract with Tetra Tech, Inc. for Environmental Engineering Services; and

WHEREAS, the City was awarded grant funding for a project referred to as the "Final Mile" from the Florida Department of Transportation (FDOT) Transportation Alternative Program (TAP) of Federal Highway Administration funds for bicycle, pedestrian and bus rider amenities at high-use bus stops and public areas along the Lower Keys Shuttle Bus route, however the grant funds are not applicable to the design and permitting phase of the project; and

WHEREAS, Tetrattech is able to provide the necessary Cultural Resource Assessments for 75 sites in an amount below the purchasing threshold, and City staff recommends authorization of a Task Order for these activities as set forth in the attached Scope of Services;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Task Order for the "Final Mile" project between the City and Tetra Tech, Inc. in an amount not to exceed \$40,896.00 is hereby approved.

Section 2: That this Task Order will be funded from the Transportation Alternative Fund Budget Account No. 111-4901-549-9803, and any necessary budget transfers or adjustments are hereby approved.

Section 3: That the City Manager is authorized to execute any necessary documents related to this Task Order.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
