










Photo of tree trunk showing old wounds, view 1.




Photo of tree trunk showing old wounds, view 2.

Value x Diameter = 12.8 replacement caliper inches




Photo of whole tree.




Photo showing tree canopy as viewed from Thompson Street in relation to roof and utility lines.




Photo of tree trunk and canopy, view 1.






Photo of tree trunk and canopy, view 2.




Photo of base of tree and trunk, view 1.





Photo of base of tree and trunk, view 2.




Photo showing tree canopy relation to house.

Location: 70% (growing in front yard, canopy influenced by utility lines and house)


Species: 50% (not on protected or not protected tree list)

Condition: 70% (overall condition is fair, no signs of decay or disease observed from ground, some canopy branch stubs from previous trimming) Total Average Value = 63%

Value x Diameter = 21.4 replacement caliper inches

Total is both trees removed 34.2 caliper inches.
