A RESOLUTION OF THE TREE COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RECOMMENDING THAT THE CITY COMMISSION APPROVE AN AMENDMENT TO CHAPTER 110 OF THE CITY OF KEY WEST CODE OF ORDINANCES "RESOURCE PROTECTION" BY AMENDING ENTITLED SECTION 110-323 ENTITLED "APPLICATION" PROVIDE FOR AN APPLICATION FOR APPLICATIONS TO THE TREE COMMISSION AND URBAN FORESTRY MANAGER; PROVIDING FOR SEVERABILITY; FOR REPEAL OF PROVIDING INCONSISTENT PROVIDING FOR PROVISIONS: ANNUAL FEE ADJUSTMENT; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 90-487 (b) of the Code of Ordinances allows the City Commission to establish fees, charges and expenses imposed by the Land Development Regulations by resolution; and

WHEREAS, there are currently no fees attached to Tree Commission applications or Urban Forestry Manager reviews; and

WHEREAS, the creation of a fee schedule is necessary to help the Urban Forestry Division review applications for compliance to the Land Development Regulations in a timely manner; and

WHEREAS, the Tree Commission finds that an amendment to the Code of Ordinances is necessary to ensure that costs associated with implementing the Land Development Regulations are borne by those parties deriving the benefit of such services; and

WHEREAS, the Tree Commission finds the proposed fees are commensurate with anticipated costs; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEY WEST
FLORIDA:
Section 1: That the proposed Tree Commission and Urban Forestr
Manager Fee Schedule (attached "Exhibit A"), are hereby approved.
Section 2: That the fees shall increase by 5% annually, to
become effective upon passage of the Ordinance by the City
Commission, and each year thereafter, until or unless amended by
Resolution to the City Commission
Section 3: That this Resolution shall go into effect
immediately upon its passage and adoption and authentication by
the signature of the Presiding Officer and the Clerk of the Tree
Commission

AN ORDINANCE OF THE CITY OF KEY WEST, FLORIDA, AMENDING CHAPTER 110 OF THE CODE ORDINANCES, ENTITLED "RESOURCE PROTECTION" BY SECTION 110-323 "APPLICATION" TO PROVIDE FOR AN APPLICATION FEE FOR APPLICATIONS TO THE TREE COMMISSION AND URBAN FORESTRY MANAGER; PROVIDING FOR SEVERABILITY: PROVIDING FOR REPEAL OF INCONSISTENT PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission for the City of Key West finds that applications to the Tree Commission and Urban Forestry Manager requires a level of staff preparation and processing of said applications that is currently not paid for or reimbursed by the applicants; and

WHEREAS, the City Commission for City of Key West finds that it is necessary to amend Sec. 110-323 to create an application fee for items that are considered by the Tree Commission and/or Urban Forestry Manager; and

WHEREAS, at its meeting of ______, 2021, the Key
West Planning Board recommended approval of this proposed
ordinance; and

WHEREAS, this amendment to Chapter 110 of the Code of Ordinances will promote the health, safety and welfare of the citizens, visitors and environment of the City of Key West.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEY WEST, FLORIDA:

Section 1: That Section 110-323 of the Code of
Ordinances is hereby amended as follows*:

Sec. 110-323. - Application; Fees.

All applications for a tree removal permit shall be made to the urban forestry manager. The application shall include an inventory of all existing trees in the area of proposed construction impact, including ingress to and egress from this area. The inventory shall state size, diameter and species of each tree. In order for the application to be acted upon, it must be signed by the property owner, or a notarized letter from the property owner must be attached to the application designating an authorized agent. The applicant shall be responsible for clearly marking the subject trees on the site with flagging tape.

A fee schedule for all applications to the Tree Commission and/or Urban Forestry Manager is attached hereto as Exhibit A and may be changed by Resolution by the City Commission.

Section 2: If any section, provision, clause, phrase, or application of this Ordinance is held invalid or unconstitutional for any reason by any court of competent jurisdiction, the remaining provisions of this Ordinance shall be deemed severable therefrom and shall be construed as reasonable and necessary to achieve the lawful purposes of this Ordinance.

Section 3: All Ordinances or parts of Ordinances of said
City in conflict with the provisions of this Ordinance are hereby
superseded to the extent of such conflict.

Section 4: This Ordinance shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission and approval by the Florida Department of Economic Opportunity, pursuant to Chapter 380, Florida Statutes.

RE: Text Amendment of the Land Development Regulations-Section 110-323,

Tree Commission and Urban Forestry Manager Fee Schedule

Request: That the Tree Commission approve the Resolution creating a text amendment

to the Land Development Regulations- A resolution of the City of Key West Tree Commission recommending approval of an ordinance to the City Commission to amend Chapter 110 of the Code of Ordinances, entitled "Resource Protection" by amending Section 110-323 entitled "Application" to provide for an application fee for applications to the Tree Commission and Urban Forestry Manager; providing for severability; providing for repeal of inconsistent provisions; providing for an effective

date.

Background:

Currently, there is no language in the Land Development Regulations regarding fees for the processing and reviews of applications by the Tree Commission or Urban Forestry Manager, therefore, a text amendment to the Land Development Regulations (LDRs) is needed.

Pursuant to Section 90-487 (b), establishment of fees, charges, and expenses imposed by the Land Development Regulations (LDRs) will be established by Resolution. The fees presented in the attached proposed Fee Schedule (Exhibit A) will establish a reasonable fee schedule to compensate for the necessary time taken by staff to review a Tree Commission application, a development project and facilitation of project through the review process, and building permit application reviews. The goal is to ensure that costs associated with implementing the LDRs are borne by those parties deriving the benefit of such services.

Staff Analysis:

The proposed fee schedule (Exhibit A) will generate necessary funds to cover the time that staff takes to review each application and project to assure completeness, quality, and compliance with the LDRs and to facilitate projects through the development review process. Staff has determined the time and labor spent processing these applications and projects is substantial and has led to the recommendation of a Fee Schedule for the associated applications and reviews.

Currently, there are no fees attached to the processing of Tree Commission permit applications, Development Plan Landscape reviews and approval by the Tree Commission and Urban Forestry Manager regarding compliance to Section 108 and Section 110 of the LDRs, or Urban Forestry Manager building permit reviews for compliance to the LDRs. The proposed Ordinance and Resolution will allow the City of Key West to establish and implement those fees.

The proposed fee schedule was created by reviewing fee schedules for numerous municipalities in the South Florida area (Exhibit B). The actual time required to do the tasks involved was also documented and used as a fee determination and current fees charged by the Planning Department and HARC were also used as a guideline.

Based on the proposed fee schedule (Exhibit A) and reviewing past Tree Commission applications and Urban Forestry Manager reviews, the potential total fee amounts for the 2019 and 2020 years would have been:

Options/Advantages/Disadvantages:

Option 1: Approve the proposed ordinance establishing a Tree Commission and Urban Forestry Manager application fee and proposed resolution approving the fee schedule.

- 1. Consistency with the City's Strategic Plan, Vision, and Mission: This action would provide enhanced services consistent with mission and vision of the City.
- **2. Financial Impact:** There will be a direct positive impact to the City by providing better recovery of the costs of providing personnel for Tree Commission and Urban Forestry functions to serve citizens.

Option 2: Do not approve the addition of fees and fee clarification.

- 1. Consistency with the City's Strategic Plan, Vision, and Mission: This action would not be consistent with providing cost effective services for the citizens wherein the applicant for a discretionary service pays for that privilege.
- **2. Financial Impact:** There would continue to be a negative impact on the fiscal health of the City in that fees are not collected for professional services provided.

Recommendation

Option 1 is recommended.
